Subject: Resolution Amending Resolution No. 396-22 to Extend the Time for Recording the Final Plat

Executive Summary

Resolution No. 396-22 granted vacation of right-of-way Petition No. P-978 to allow the applicant to incorporate the land into the proposed plat of "ADES FAMILY FOUNDATION," tentative Plat T-24650. As a condition of the approval, the applicant was required to record the final plat within one year of the resolution's approval. The applicant has requested additional time for the recording of the final plat in order to complete the pending items associated with the approval of the plat, i.e., paving and drainage plans approval and posting of bond. This resolution extends the time for the recording of the final plat to satisfy the condition from one year to four years from the effective date of Resolution No. 396-22. This extension of time has the support of the Platting Section of the Department of Regulatory and Economic Resources (RER) and is considered sufficient time to allow the applicant to complete the platting process. There is no fiscal impact associated with this item.

Recommendation

It is recommended that the Board approve the attached resolution amending Resolution No. 396-22 to extend the time for the recording of the plat of "ADES FAMILY FOUNDATION," tentative Plat T-24650 as a condition of the previous vacation of right-of-way.

Scope

The subject property is located within District 2, which is represented by Commissioner Marleine Bastien.

Fiscal Impact/Funding Source

There is no fiscal impact associated with the amendment.

Delegated Authority

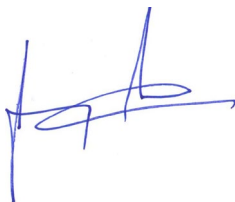
There is no delegation of authority associated with this item.

RESOLUTION AMENDING RESOLUTION NO. R-396-22, WHICH GRANTED VACATION OF RIGHT-OF-WAY PETITION NO. P-978 TO CLOSE A PORTION OF NW 95 STREET FROM NW 8 AVENUE WEST FOR 117.1 FEET, AND NW 9 AVENUE FROM NW 96 STREET SOUTH FOR 142.4 FEET SUBJECT TO CERTAIN CONDITIONS, AND EXTENDING THE TIME TO COMPLY WITH SUCH CONDITIONS

WHEREAS, on May 3, 2022, this Board adopted Resolution No. 396-22, granting a petition to close a portion of NW 95 Street from NW 8 Avenue west for 117.1 feet and NW 9 Avenue from NW 96 Street south for 142.4 feet subject to certain conditions; and

WHEREAS, as a condition of approval, this Board required tentative Plat T-24650, "ADES FAMILY FOUNDATION," which incorporated the land from the road closing, to be recorded within one year; and

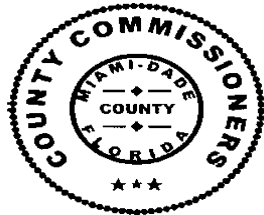
WHEREAS, the platting process has not been finalized and the applicant needs additional time to have the plat approved and recorded,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board incorporates and approves the foregoing recitals and County Mayor's Memorandum as if fully set forth herein; amends section 3 of Resolution No. 396-22 and extends the time for the recording of the final plat to satisfy the condition from one year to four years from the effective date of Resolution No. 396-22 such that section 3 of Resolution No. 396-22 shall now read "If the plat is not recorded within four years, this resolution shall be null and void"; and leaves in place all other terms and conditions of Resolution No. 396-22.
