RESOLUTION NO. _____ R-260-23

RESOLUTION CODESIGNATING THAT PORTION OF
SOUTHWEST 167TH AVENUE BETWEEN SOUTHWEST
282ND STREET AND SOUTHWEST 288TH STREET AS
“BUCCANEER BOULEVARD”

WHEREAS, South Dade Senior High School (South Dade SHS) is a secondary school located on 60 acres in unincorporated Miami-Dade County, Florida, just to the north of the City of Homestead; and

WHEREAS, established in 1953, the South Dade SHS is the oldest of the two public high schools that serve parts of the City of Homestead, Redland, Naranja, Leisure City, and other unincorporated areas of the County; and

WHEREAS, as the second largest traditional high school in the Miami-Dade County Public Schools system, South Dade SHS is currently structured as a neighborhood school and magnet school with International Baccalaureate and five other academic programs that draw students from throughout the region; and

WHEREAS, situated in what has traditionally been an agricultural area, recent housing developments at the northern, southern, and western end of the attendance zones have caused a steady increase in South Dade SHS’s student population in recent years; and

WHEREAS, the South Dade SHS is home of the Buccaneers, where it is celebrated that “There is no Peer to a Buccaneer”; and

WHEREAS, this Board wishes to celebrate South Dade SHS’s continued contribution to the development of the County by codesignating that portion of Southwest 167th Avenue between Southwest 282nd Street and Southwest 288th Street as “Buccaneer Boulevard”; and

WHEREAS, that portion of Southwest 167th Avenue between Southwest 282nd Street and Southwest 288th Street is a County-maintained road located in unincorporated Miami-Dade County; and

WHEREAS, the proposed codesignation is located in County Commission District 8,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

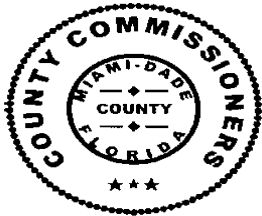
Section 1. Having considered this matter at a public hearing, this Board codesignates that portion of Southwest 167th Avenue between Southwest 282nd Street and Southwest 288th Street as “Buccaneer Boulevard”.

Section 2. This Board directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Danielle Cohen Higgins. It was offered by Commissioner **Eileen Higgins** , who moved its adoption. The motion was seconded by Commissioner **Oliver G. Gilbert, III** and upon being put to a vote, the vote was as follows:
