RESOLUTION NO. _____ R-246-23

RESOLUTION APPROVING THE CITY OF AVENTURA'S CODESIGNATION OF THAT PORTION OF NE 190TH STREET BETWEEN W COUNTRY CLUB DRIVE AND THE ENTRANCE OF THE HIDDEN BAY RESIDENTIAL COMMUNITY AS "HIDDEN BAY DRIVE"; APPROVING THE CITY OF AVENTURA'S REMOVAL OF THE "MARINA DEL RAY BOULEVARD" CODESIGNATION FROM THAT PORTION OF NE 190TH STREET BETWEEN W COUNTRY CLUB DRIVE AND THE ENTRANCE OF THE HIDDEN BAY RESIDENTIAL COMMUNITY

WHEREAS, the Hidden Bay residential community ("Hidden Bay") is the cornerstone community located in the City of Aventura at the end of the portion of NE 190th Street east of W Country Club Drive; and

WHEREAS, said portion of NE 190th Street between W Country Club Drive and the entrance of Hidden Bay is currently codesignated as "Marina Del Rey Boulevard"; and

WHEREAS, the residents of the Hidden Bay community support changing the codesignation of this street from "Marina Del Rey Boulevard" to "Hidden Bay Drive"; and

WHEREAS, accordingly, on March 7, 2023, the City Commission of the City of Aventura adopted Resolution No. 2023-12, which removed the "Marina Del Rey Boulevard" codesignation from that portion of NE 190th Street between W Country Club Drive and the entrance of Hidden Bay and instead codesignated such street as "Hidden Bay Drive"; and

WHEREAS, a copy of Resolution No. 2023-12 is attached hereto and incorporated by reference; and

WHEREAS, the City of Aventura would like the County to install signage indicating this codesignation on County street signs and traffic signal masts arms; and

WHEREAS, that portion of NE 190th Street between W Country Club Drive and the entrance of Hidden Bay is a city-maintained road located in the City of Aventura; and

WHEREAS, this codesignation is located in County Commission District 4,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Aventura's codesignation of that portion of NE 190th Street between W Country Club Drive and the entrance of the Hidden Bay residential community as "Hidden Bay Drive."

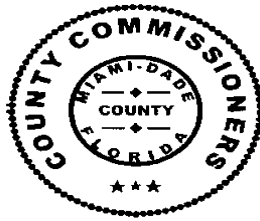
Section 2. Approves the City of Aventura's removal of the "Marina Del Rey Boulevard" codesignation from that portion of NE 190th Street between W Country Club Drive and the entrance of the Hidden Bay residential community.

Section 3. Directs the Clerk of the Board to send certified copies of this Resolution to the City Commission of the City of Aventura, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the Aventura Police Department and the Miami-Dade Fire-Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Micky Steinberg. It was offered by Commissioner **Anthony Rodriguez**, who moved its adoption. The motion was seconded by Commissioner **Oliver G. Gilbert, III** and upon being put to a vote, the vote was as follows:

CITY OF AVENTURA RESOLUTION NO. 2023-12

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF AVENTURA, FLORIDA, CO-DESIGNATING NE 190th STREET FROM COUNTRY CLUB DRIVE TO THE ENTRANCE OF THE HIDDEN BAY RESIDENTIAL COMMUNITY AS “HIDDEN BAY DRIVE”; DIRECTING THE CITY CLERK TO SUBMIT THIS RESOLUTION TO MIAMI-DADE COUNTY; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Aventura, in conjunction with Miami-Dade County, has the authority to name streets within the City’s jurisdiction for use as a specific reference point for a geographic area in the City and/or to reflect the character of the neighborhood; and

WHEREAS, the Hidden Bay residential community (“Hidden Bay”) is the cornerstone community located on the end of the street currently known as Marina Del Rey Boulevard/NE 190th Street, located east of Country Club Drive to the entrance of Hidden Bay; and

WHEREAS, the residents of the Hidden Bay community support the co-designation of this street to Hidden Bay Drive; and

WHEREAS, the City Commission finds that this Resolution is in the best interest of the City and its residents to co-designate this street as Hidden Bay Drive.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF AVENTURA, FLORIDA:

Section 1. Recitals Adopted. That the above stated recitals are hereby adopted and confirmed.

Section 2. Hidden Bay Drive Co-Designation. That the City Commission hereby co-designates the street east of Country Club Drive to the entrance of the Hidden Bay residential community by removing the name “Marina Del Rey Boulevard” and renaming it “Hidden Bay Drive”, and shall as soon as authorized by Miami-Dade County, be known in and by the City of Aventura as NE 190th Street and “Hidden Bay Drive.” Upon County approval, signs shall be made and installed above the present place declaring such designation.

Section 3. Implementation. That the City Clerk is hereby directed to submit this Resolution to Miami-Dade County and other appropriate agencies, and along with the City Manager, take all action necessary to implement this Resolution.

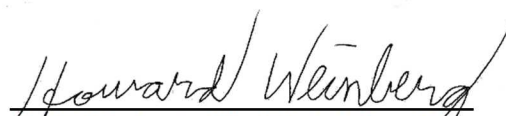
Section 4. Effective Date. That this Resolution shall become effective immediately upon its adoption.
