RESOLUTION NO. _____ R-373-23

RESOLUTION DIRECTING THE COUNTY MAYOR OR
COUNTY MAYOR'S DESIGNEE TO DESIGN AND
IMPLEMENT A PARK ZONES PILOT PROGRAM ON ROADS
ADJACENT TO OR IN CLOSE PROXIMITY TO CERTAIN
PARKS IN MIAMI-DADE COUNTY; AND REQUIRING
REPORTS

WHEREAS, this Board is committed to enhancing the quality of life of residents and visitors to Miami-Dade County through the promotion of healthy activities such as playing sports, walking, running, and cycling; and

WHEREAS, within the County, there are over 285 County parks, in addition to many more state and municipal parks; and

WHEREAS, the existence of such parks positively impacts the quality of life of the County's residents and visitors; and

WHEREAS, many parks are bordered by, or exist in close proximity to state, county, and municipal roads; and

WHEREAS, pedestrians are among the most vulnerable road users and Florida has consistently ranked among the highest of all states nationally in rates of pedestrian deaths; and

WHEREAS, according to a recent study conducted by Florida's Office of Program Policy Analysis and Government Accountability, titled "Pedestrian Safety Near Parks in Miami-Dade County," from 2015 to 2019, Miami-Dade County had 5,429 crashes involving 5,740 injured pedestrians and almost 55 percent of crashes resulting in injured pedestrians occurred in a park buffer compared to outside of it; and

WHEREAS, the study indicated that the County's large number of parks and recreational areas, as well as its high population density, may have contributed to the high number of pedestrian crashes near parks; and

WHEREAS, according to the report, speed is one of the most important factors in the likelihood and severity of pedestrian-involved crashes, and pedestrian-heavy areas, such as parks, may be more likely to experience pedestrian crashes; and

WHEREAS, the report also suggests that traffic operations on roads near parks, including speed limits, may have an effect on the overall safety of persons wishing to access parks in the County; and

WHEREAS, according to the National Highway Traffic Safety Administration, on average three children were killed, and an estimated 502 children were injured, every day in traffic crashes in 2019; and

WHEREAS, the Miami-Dade County Youth Commission, which is charged with advising the Board and the County Mayor on matters affecting the youth and teen population in the County, has actively advocated for the creation of reduced-speed zones around parks, or "park zones," to ensure the safety of park and recreation users; and

WHEREAS, similar initiatives have been implemented around the country, such as the State of Illinois establishing "Safe Park Zones" in 2006 in order to lower the speed limits in sections of roadway near parks; and

WHEREAS, the Board is empowered under section 316.189, Florida Statutes, to set custom speed zones on County-maintained roads "after investigation determines such a change is reasonable and in conformity to criteria promulgated by the Department of Transportation, except that no such speed zone shall permit a speed of more than 60 miles per hour[]"; and

WHEREAS, Florida law provides a mechanism for the establishment and enforcement of certain speed limits around schools, known as “school zones”; and

WHEREAS, having a uniform approach to traffic management, including through the implementation of “park zones,” similar to existing “school zones,” on roads adjacent to or in close proximity to parks in the County, could be in best interest of the County; and

WHEREAS, this Board wishes to direct the County Mayor or County Mayor’s designee to design a pilot program implementing park zones around certain parks in Miami-Dade County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

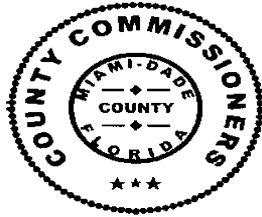
Section 1. Directs the County Mayor or County Mayor’s designee to design and implement a Park Zones pilot program on County-maintained roads at five County-owned parks located in Miami-Dade County, excluding parks already encompassed in school zones. At a minimum, the pilot program should: (1) be designed with the consideration of which parks are adjacent to County roads with the highest number of pedestrian traffic accidents; (2) examine whether speed reductions on County-maintained roads adjacent to County parks, or other engineering changes and traffic calming measures (such as improved lighting on park perimeters or textured pavement), can positively impact the safety of park visitors, including children, pedestrians, and cyclists; (3) identify any partnerships with the state or municipalities required to implement any such speed reductions or other engineering changes; (4) design and conduct an educational campaign to improve pedestrian and motorist awareness of traffic rules; and (5) identify and use legally available funding sources from within the fiscal year 2022-2023 County budget and include funding for this purpose in the proposed budget for fiscal year 2023-2024.

Section 2. Directs the County Mayor or County Mayor’s designee to provide a report to the Board within 180 days of the effective date of this resolution describing the design of the pilot program, its implementation, results of the pilot program, and recommendations as to expanding the program County-wide. Alternatively, if the County Mayor or County Mayor’s designee is unable to identify legally available funds for the purposes set forth in this resolution, the County Mayor or County Mayor’s designee shall provide a written report to the Board within 60 days of the effective date of this resolution setting forth any reasons why funds have not been identified or cannot be used or allocated for such purposes. The reports shall be placed on an agenda of the full Board without committee review pursuant to rule 5.06(j) of the Board’s Rules of Procedure.

The Prime Sponsor of the foregoing resolution is Commissioner Eileen Higgins. It was offered by Commissioner **Eileen Higgins** , who moved its adoption. The motion was seconded by Commissioner **Oliver G. Gilbert, III** and upon being put to a vote, the vote was as follows:
