2022-23 DISTRICT 4 DISCRETIONARY RESERVE

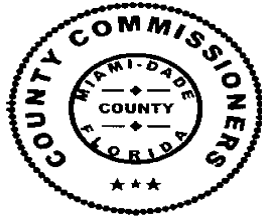
**WHEREAS**, this Board desires to allocate funds from the FY 2022-23 District 4 Discretionary Reserve in accordance with the attached memorandum,
