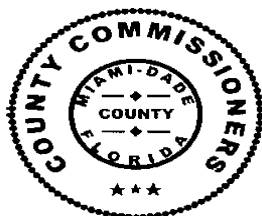
WHEREAS, this Board desires to allocate and rescind funds from the FY 2022-23 and the
