FY 2022-23 DISTRICT 12 DESIGNATED PROGRAM

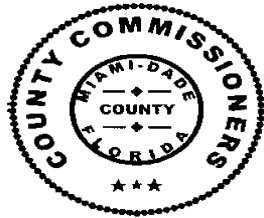
WHEREAS, this Board desires to allocate funds from the FY 2022-23 District 12 Designated Program in accordance with the attached memorandum,
