FY 2022-23 DISTRICT 12 DISCRETIONARY RESERVE

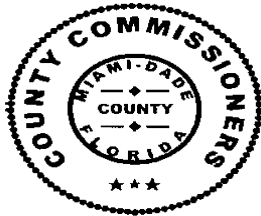
WHEREAS, this Board desires to allocate funds from the FY 2022-23 District 12 Discretionary Reserve in accordance with the attached memorandum,
