2022-23 DISTRICT 1 DISCRETIONARY RESERVE

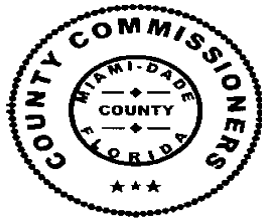
**WHEREAS**, this Board desires to allocate funds from the FY 2022-23 District 1 Discretionary Reserve in accordance with the attached memorandum,
