WHEREAS, this Board desires to rescind funds from the FY 2021-22 District 11 Discretionary Reserve in accordance with the attached memorandum,

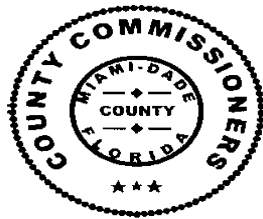
