Conveyance of Non-Exclusive Utility Easements to Florida Power and Light **Subject:**

Company to Provide Electrical Service to the South Dade Transit Operations

Executive Summary

The purpose of this item is to gain approval of the Board of County Commissioners (Board) to convey non-exclusive utility easements to Florida Power and Light Company (FPL) for provision of electric power service to the South Dade Transit Operations Center. The Center will house a fleet of up to 100 electric buses, and the easements are required for FPL to service the Center. Under the conveyance, there is no fiscal impact to the County.

The South Dade Transit Operations Center is a new facility that will improve operational efficiency by dramatically reducing turnaround time for returning buses to service, decreasing out of service mileage. The Center is currently in the design phase and is scheduled to be fully constructed and operational by March 2025. In addition to housing and maintaining the electric bus fleet, the Center will have offices for the Department of Transportation and Public Works' revenue operations, Office of Training and Traffic Signals and Signs Division.

Recommendation

It is recommended that the Board authorize the conveyance of non-exclusive utility easements to FPL to provide for the installation, construction, operation, and maintenance of electrical facilities to service the South Dade Transit Operations Center.

Scope

The proposed easements are located on County-owned land at the South Dade Transit Operations Center, physically at SW 127 Avenue and Biscayne Drive, Homestead, Florida, in District 9, represented by Commissioner Kionne L. McGhee. However, as the Operations Center will enhance the performance of the entire transit system, there will be a countywide impact.

Delegation of Authority

This item authorizes the County Mayor or the County Mayor's designee to execute the easements and exercise all provisions contained therein and to amend Exhibit A and Exhibit B of the easements to revise the survey and legal description of the easement areas to conform with the asbuilt location of the utility facilities so long as the utility facilities have been positioned within 25 feet of the originally proposed location and the total area is no greater than 25 percent of the originally proposed easement area.

Fiscal Impact/Funding Source

The easements will be conveyed to FPL for a nominal sum of \$1.00. There is no other fiscal impact to the County associated with the conveyance of the easements.

Track Record/Monitor

The person responsible for monitoring the proposed easement is Javier Bustamante, Department of Transportation and Public Works, Assistant Director, Transit Project Management and Support Services.

Background

As development in Miami-Dade County continues to expand southerly, the need to provide quality, on time transit services to residents increases, necessitating a maintenance facility for the Department of Transportation and Public Works' bus fleet within the South Dade area. Furthermore, the forthcoming completion of the South Corridor of the Strategic Miami Area Rapid Transit Program (i.e., the SMART Program and the South Dade TransitWay) requires servicing the electric bus fleet that will operate along the corridor. The South Dade Transit Operations Center was added to the Fiscal Year 2021-25 update to the Five-Year Implementation Plan of the People's Transportation Plan.

The South Dade Transit Operations Center will be located at SW 288 Street (Biscayne Drive) and SW 127 Avenue on County-owned property. The facility is currently in the design phase and is scheduled to be fully constructed and operational by March 2025.

The placement of easements needed for electrical service to the new facility has already been determined. One easement will provide power connection to the FPL transformer vault. The other easement will be located along Biscayne Drive for the FPL distribution power lines. Consequently, to ensure that the installation of electrical service facilities coincides with the construction schedule and are installed and operational prior to the completion of construction, the Department of Transportation and Public Works is requesting the conveyance of the easements at this time. The FPL lines serving the facility shall be directly buried underground for aesthetic presentation, with no or very little aboveground appearance.

FPL has advised that in the event of complete non-use of the underground utility easement for a period of two consecutive years, or if the County abandons the project and no longer uses the FPL facilities, the County can request that FPL initiate the process to release the easement and to remove the FPL facilities from the easement area at the expense of the County. To release the easement, FPL will need to deliver a duly executed release of the easement in recordable form to the County.

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Incorporates and approves the foregoing recitals as if fully set forth herein.

Section 2. Approves the conveyance of non-exclusive easements to Florida Power and Light Company ("FPL") for \$1.00 to install, operate and maintain electrical power facilities at the South Dade Transit Operations Center located in the vicinity of SW 127 Avenue and Biscayne Drive, Homestead, Florida, in substantially the form attached hereto as Exhibit "A" and Exhibit "B" (the "easements"), for the purpose of providing electrical service to the South Dade Transit Operations Center.

Section 3. Authorizes the County Mayor or County Mayor's designee to execute the easements for and on behalf of Miami-Dade County, exercise all provisions contained therein, to take all actions to effectuate same, and to amend Exhibit A and Exhibit B, to revise the survey and legal description of the easement areas to conform with the as-built locations of the utility facilities so long as the utility facilities have been positioned within 25 feet of the originally proposed locations and the total area is no greater than 25 percent of the originally proposed easement area.

Section 4. Directs the County Mayor or County Mayor's designee, pursuant to Resolution No. R-974-09, to record the easement and any amendments thereto, as referenced in section 3 above, in the public records of the County and provide a recorded copy to the Clerk of the Board within 30 days of execution of said instruments and directs the Clerk of the Board to permanently store the recorded copies with this resolution.
