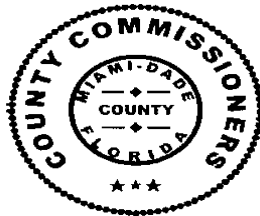
WHEREAS, this Board desires to allocate funds from the FY 2022-23 District 1 Designated Program in accordance with the attached memorandums,
