2022-23 DISTRICT 3 DISCRETIONARY RESERVE

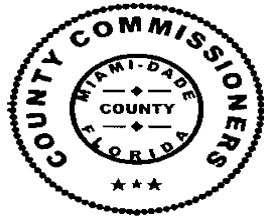
WHEREAS, this Board desires to allocate funds from the FY 2022-23 District 3 Discretionary Reserve in accordance with the attached memorandum,
