2022-23 DISTRICT 8 CBO DISCRETIONARY RESERVE

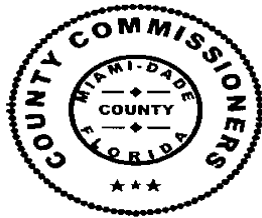
WHEREAS, this Board desires to allocate funds from the FY 2022-23 District 8 CBO Discretionary Reserve in accordance with the attached memorandums,
