Subject: Resolution Approving the Plat of Eureka Point Gardens Amended Filed by Adrian Builders at Eureka Point Gardens, LLLP

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Eureka Point Gardens Amended is bounded on the north approximately 90 feet south of SW 182 Lane, on the east approximately 340 feet west of SW 109 Avenue, on the south by SW 184 Street, and on the west by SW 110 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 9, which is represented by Commissioner Kionne L. McGhee.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the county would be approximately \$350.00 annually for the maintenance of new roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

- Proposed Usage: 58 apartment units.
- Number of Parcels: One.
- This plat meets concurrency.
- Available public water and sewer lines abut the proposed subdivision. The parcels are required to connect to public water and public sanitary sewers.

Developer's Obligation

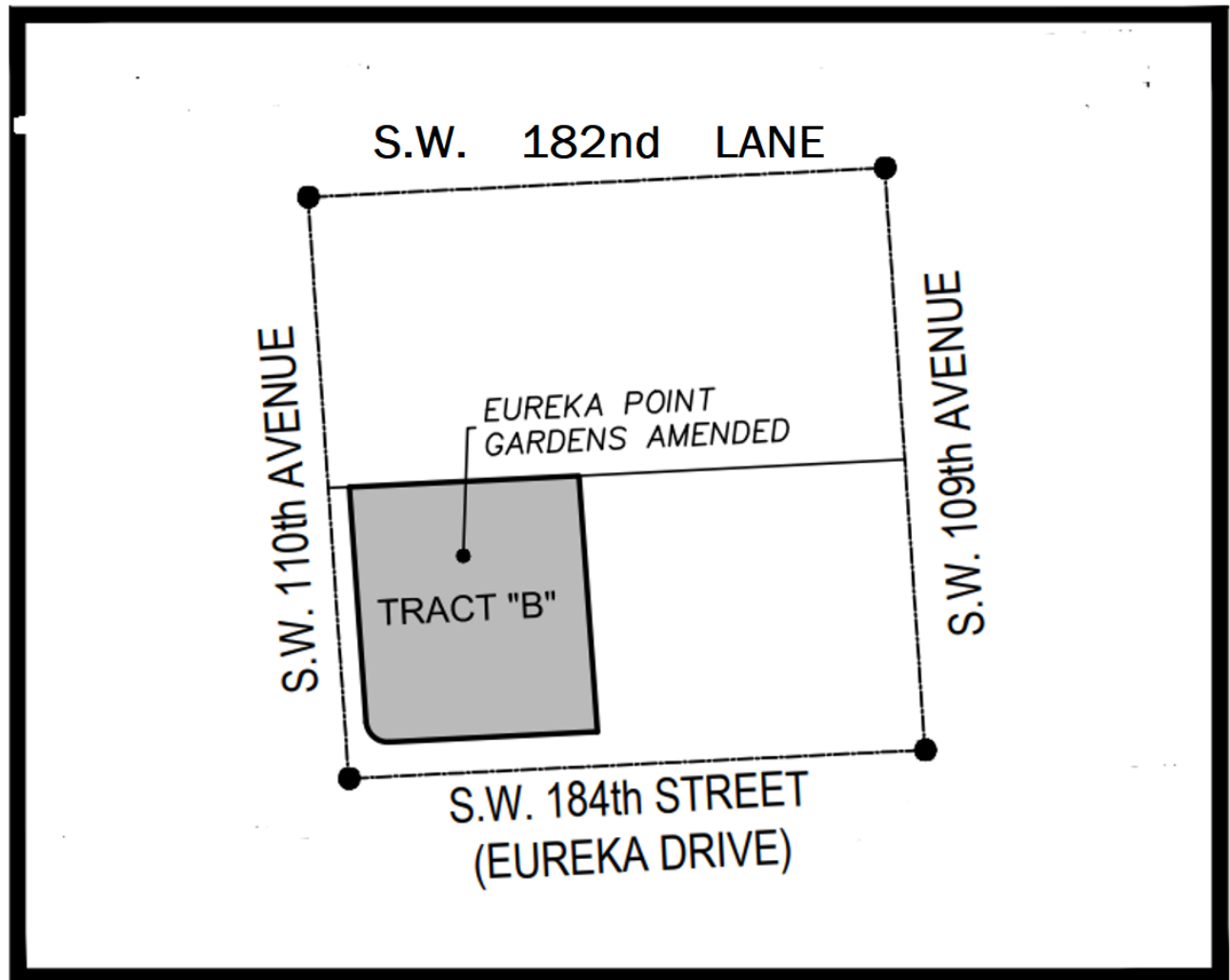

EUREKA POINT GARDENS AMENDED

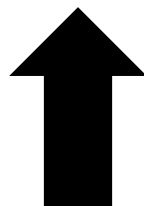

RESOLUTION APPROVING THE PLAT OF EUREKA POINT GARDENS AMENDED, FILED BY ADRIAN BUILDERS AT EUREKA POINT GARDENS AMENDED, LLLP, LOCATED IN THE SOUTHEAST 1/4 OF SECTION 31, TOWNSHIP 55 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 90 FEET SOUTH OF SW 182 LANE, ON THE EAST APPROXIMATELY 340 FEET WEST OF SW 109 AVENUE, ON THE SOUTH BY SW 184 AVENUE, AND ON THE WEST BY SW 110 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, Adrian Builders at Eureka Point Gardens, LLLP, a Florida limited liability limited partnership, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, said plat to be known as “Eureka Point Gardens Amended,” the same being a replat of Lots 1 thru 9 in Block 1, and Lots 1 thru 12, in Block 2, and Tract “A,” of “Eureka Point Gardens,” according to the plat thereof, as recorded in Plat Book 167, at Page 53 of the Public Records of Miami-Dade County, Florida, lying and being in the Southeast 1/4 of Section 31, Township 55 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

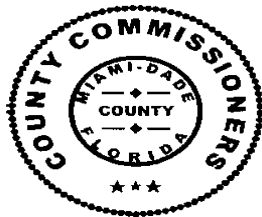
NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed

on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
