Executive Summary

The purpose of this item is for the Board of County Commissioners to ratify the action of the County Mayor or Mayor's Designee, as authorized under the County's Economic Stimulus Plan Ordinance, for the award of a construction contract to Lunacon Engineering Group, Corp., DBA Lunacon Construction Group, Corp. in the amount of \$5,853,573 for renovations to the Zoo Miami Amphitheater. The project includes exhibit space and provides a new themed entry feature that will enhance the amphitheater visitor experience. The new holding facilities will satisfy holding requirements for both the Association of Zoos and Aquariums (AZA) accreditation and Florida Wildlife Conservation Commission (FWC) regulations.

Recommendation

It is recommended that the Board of County Commissioners (Board) ratify the action of the County Mayor or Mayor's Designee, as authorized under the County's Economic Stimulus Plan (ESP) Ordinance (Section 2-8.2.7 of the Code of Miami-Dade County) for the award of the construction contract in the amount of \$5,853,573 to Lunacon Engineering Group, Corp., DBA Lunacon Construction Group, Corp. for the Zoo Miami Amphitheater Holding Renovations Re-Bid ESP, Contract: ZC2022AHR-A, Project No: 59250018004.

Scope

The Miami-Dade County Parks, Recreation and Open Spaces Department's (PROS) Zoo Mami is located at 12400 SW 152 Street, Miami, FL 33177, within County Commission District 9, which is represented by Commissioner Kionne L. McGhee; however, Zoo Miami is an asset of County-wide significance.

Fiscal Impact/Funding Source

The funding sources for this project are \$181,155 of Building Better Communities General Obligation Bond Program (GOB) funds, \$5,672,418 of Countywide Infrastructure Investment Plan (CIIP) funds for a total of \$ 5,853,573, as outlined in Attachment A. These capital programs were included in the County's FY 2022-23 adopted budget and multi-year capital plan.

Delegation of Authority

The authority of the County Mayor or County Mayor's designee to execute and implement this contract is consistent with those authorities granted under the Code of Miami-Dade County. Approval of this project is pursuant to the County's Economic Stimulus Plan Ordinance (Section 2-8.2.7 of the Miami-Dade County Code).

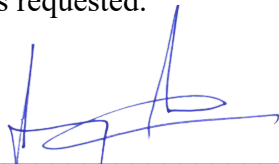
Track Record/Monitor

The PROS Planning, Design, and Construction Excellence Division Contract Manager, Mr. Michael J. Cornely, will oversee the implementation of this project. Mr. Chad Douglas will be the Project Manager overseeing this project throughout the construction phase. The impact of sea level rise has been considered in this project.

Background

The purpose of the ESP Program is to provide an expedited process to award certain contracts with the express purpose of stimulating the local economy. The ESP Program continues to be an effective way of accelerating the County's capital improvement program by expediting funded projects through the contract approval process.

The contract for the improvements to Zoo Miami Amphitheater Holding Renovations Re-Bid includes but is not limited to demolition as required and renovations to the existing amphitheater. The project will be scheduled and phased according to the plans. Attachment A is the recommendation to award the construction contract and includes the details of the competitively bid award for which ratification is requested.

Executive Summary

The purpose of this item is to enter into a contract with Lunacon Engineering Group, Corp., DBA Lunacon Construction Group, Corp. in the amount of \$ 5,853,573.00 for Zoo Miami - Amphitheater Holding Renovations - Re-Bid. This contract will then be submitted for ratification by Miami-Dade County Board of County Commissioners pursuant to Section 2-8.2.7 of the Code of Miami-Dade County (Code), known as the Economic Stimulus Ordinance. Zoo Miami - Amphitheater Holding Renovations were added to the County's Economic Stimulus (ESP) list by Resolution No. R-133-10.

Install caging, gates, footers, drinkers, walls, electrical, and plumbing for the Amphitheater Holding Renovation. Erect a 6' temporary chain link construction fence around the job site prior to Demolition. Include green windscreen and maintain throughout the project. Provide temporary toilet facilities for workers throughout the duration of the project. Provide shop drawings as required by the Architect of Record. Complete all installations per the attached Plans and Specifications. Install concrete per plans. Design mix to include the following minimum specifications: 5000 psi, fiber-enriched, and Xypex or approved waterproofing agent. Include the installation of (WMMR) stucco on Masonry Walls. Include coating the walls with high-performance 2-part urethane primer and 2 topcoats of 2-part urethane paint. Fill all Masonry Wall cells with concrete.

DBA HE Builders was deemed non-responsible due to failure to respond to the request to provide additional information regarding past experience. The second lowest bidder Lunacon

Engineering Group, Corp., DBA Lunacon Construction Group, Corp. provided a base bid of \$5,177,000.00 (see attached Bid Tabulation).

This project has a 14.13% SBE-Con subcontractor goal Lunacon Engineering Group, Corp., DBA Lunacon Construction Group, Corp. has satisfied the contract's 14.13% SBE-Con subcontractor goal and is in compliance with the overall Small Business measures established for this contract. Parks performed the all pre-award verifications and the current low bidder complied with all applicable County Ordinances, and regulations. Please see Attachments 1 through 7.

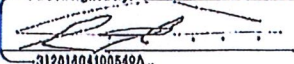

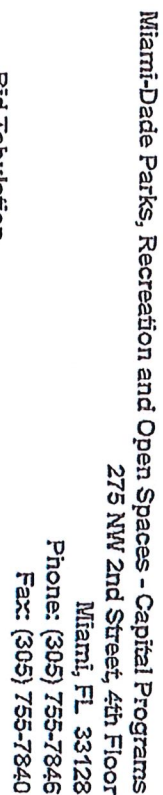

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

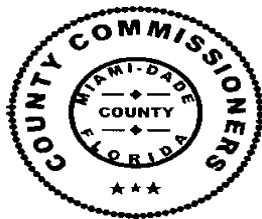
