Subject: Request for Reimbursement to County Employee for Loss of Personal Property

Executive Summary

The purpose of this item is for the Miami-Dade Board of County Commissioners (Board) to approve payment in the amount of \$4,075.69 to Department of Transportation and Public Works (DTPW) Facilities Equipment Technician, Grace Stallworth-Papino, as reimbursement for loss of personal property incurred in connection with her employment. This reimbursement request complies with Section 2-11.13 of the County Code, which sets forth the policy of providing reasonable reimbursement to County employees for the loss or damage to their personal property when the (1) loss or damage was incurred in the discharge of the employee's duties on official County business; (2) loss or damage was not otherwise compensated or reimbursed; (3) loss or damage was not the result of the employee's negligence; (4) loss or damage was not caused by the negligence or willful act of a third party who is liable for said loss or damage, or that if said loss or damage was caused by the negligence or willful act of a third party that it would be unreasonable to expect the employee to attempt recovery from said third party; and (5) the amount or reimbursement for the loss or damage is reasonable. That policy includes execution of a subrogation agreement which shall be complied with.

Ms. Stallworth-Papino discovered her toolbox missing from her worksite when she arrived on June 5, 2022; soon thereafter, a police report was issued and a Notice of Loss was submitted, which was reviewed and approved for reimbursement by the required County departments – Office of Management and Budget (OMB), Internal Services Department (ISD) Risk Management and DTPW.

Recommendation

It is recommended that the Board approve a tool reimbursement request in the amount of \$4,075.69 to compensate DTPW Facilities Equipment Technician, Grace Stallworth-Papino, for loss of personal property. In accord with Section 2-11.13 of the County Code and Administrative Order No. 7-23, OMB, ISD Risk Management and DTPW reviewed and approved Ms. Stallworth-Papino's Notice of Loss claim.

Fiscal Impact/Funding Source

The fiscal impact to the County is in the amount of \$4,075.69. The reimbursement will be funded through DTPW's Operating Fund.

Track Record/Monitor

DTPW's Chief Financial Officer, Melvin Cartagena, will oversee the reimbursement to Grace Stallworth-Papino.

Delegated Authority

There is no delegation of authority associated with this item.

Background

Pursuant to Section 2-11.13 of the Miami-Dade County Code and Administrative Order No. 7-23, it is the policy of the County to provide reasonable reimbursement to County employees for the loss of damage to their personal property. Employees whose job assignments entail the possession of a prescribed list of tools will be reimbursed for the loss of those tools upon affirmation by their supervisor that the employees did in fact possess the

required tools. Employees who bring to work tools other than such required tools, and who would wish to be reimbursed for these other tools in case of their loss, must have on file with their supervisors current itemized listings of such tools, and, in case of their loss, the supervisors must affirm that to the best of their knowledge, said tools were among the items lost. Without such a list and affirmation by the supervisors, no reimbursement will be made for the loss of tools that employees are not required to have on the job.

On June 5, 2022, at approximately 6:15am, DTPW Facilities Equipment Technician, Grace Stallworth-Papino, discovered her toolbox missing when she arrived at her worksite. More specifically, the passenger door lock of her work van was damaged and the black toolbox was missing. DTPW submitted a tool reimbursement request on April 23, 2023 for Ms. Stallworth-Papino, including a cost itemization of the stolen tools, totaling \$4,075.69.

This reimbursement claim satisfies County policy for such requests as the loss was incurred in the discharge of Ms. Stallworth-Papino's duties, was not due to her negligence and could not otherwise be compensated. OMB, ISD Risk Management and DTPW have reviewed and approved this tools reimbursement request.
