Subject: Resolution Approving the Waiver of Plat of Edward Boza & Kathryn F. Boza & Kathryn A. Boza filed by Edward Boza & Kathryn F. Boza & Kathryn A. Boza

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for Edward Boza & Kathryn F. Boza & Kathryn A. Boza, is bounded on the north by SW 72 Street, on the east approximately 570 feet west of Mindello Street, on the south approximately 360 feet north of SW 74 Street and on the west by SW 47 Avenue.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 7, which is represented by Commissioner Raquel A. Regalado.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Background

Edward Boza & Kathryn F. Boza & Kathryn A. Boza (D-24688)

- Located in Section 32, Township 54 South, Range 41 East.
- Zoning: EU-1.
- Proposed usage: Two single family residences.
- Number of parcels: Two.
- This waiver of plat meets concurrency.
- This waiver of plat was determined to be within feasible distance to public water but not within feasible distance to public sanitary sewers pursuant to the new feasible distance Ordinance no. 22-137.
- As a condition of this waiver of plat approval, the proposed subdivision will be required to connect to public water and to an onsite sewage treatment and disposal system (OSTDS).
- The proposed subdivision will be required to install a Type 3 OSTDS to comply with the new OSTDS requirements adopted in Ordinance No. 22-83.

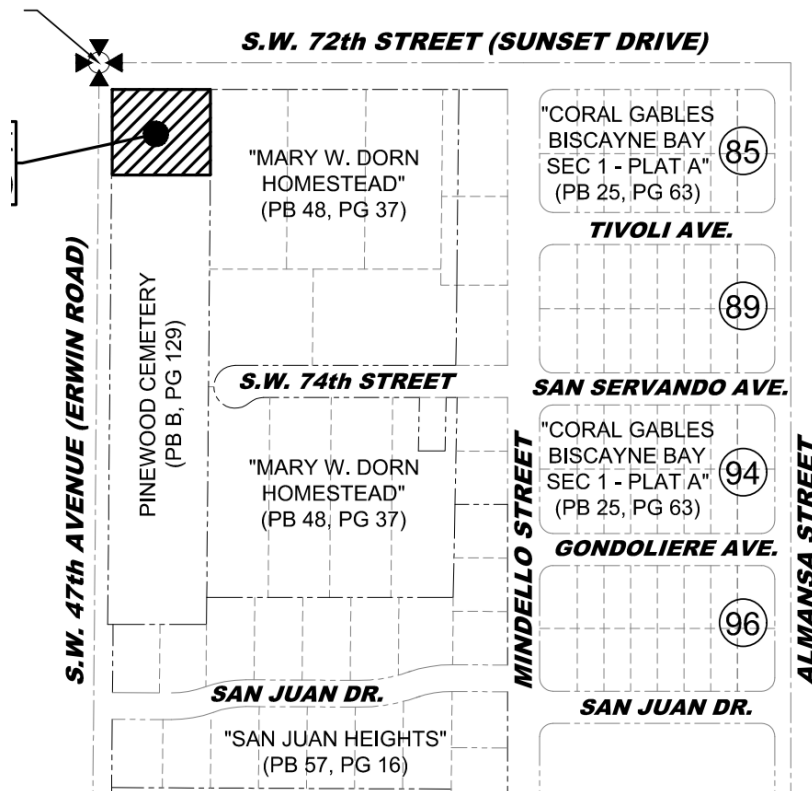

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

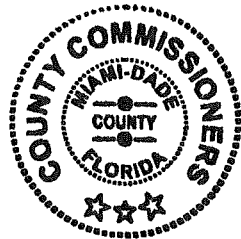
