Subject: Resolution Approving the Terms and Retroactively Authorizing the Execution of an Authorized Access Form Between SoundThinking, Inc. and Miami-Dade County Providing Ummah Futures International LLC Access to ResourceRouter Community Subscription Services Data

Executive Summary

This item approves the terms of and retroactively authorizes the County Mayor or County Mayor's designee to execute an Authorized Access Form (Form), attached to the resolution and labeled Exhibit A, between SoundThinking, Inc. (SoundThinking) and Miami-Dade County (County), through the Miami-Dade Police Department (MDPD), for a term that began upon signature by the parties and expires on the 15th day following notice of termination. SoundThinking, formerly ShotSpotter is a public safety technology company that combines solutions and advisory services to make neighborhoods safer and improve community confidence that provides valuable software solutions to the MDPD. ResourceRouter, one of the four software solutions offered by SoundThinking, is a patrol and analyst tool that automates the planning of directed patrol assignments. SoundThinking requires that the County execute the Form authorizing SoundThinking to provide Ummah Futures International LLC (Ummah) with access to MDPD's ResourceRouter Community Subscription Services data so that Ummah can dispatch community violence interventions (i.e., violence interrupters) in much the same way as police officers are dispatched. Miami-Dade County has a long-standing relationship with Ummah and its President, Mr. Wayne Rawlings, who has had a contract with the County via the Juvenile Services Department since 2019 for Anti-Violence Initiative Project Management.

The County, through the MDPD, is a current ResourceRouter end user and desires to provide Ummah with access to certain historical and ongoing RMS¹ data. No personally identifiable or CJIS² data shall be shared with Ummah when providing access to the MDPD's ResourceRouter Community subscription services.

Recommendation

It is recommended that the Miami-Dade Board of County Commissioners (Board) approve the attached resolution approving the terms of and retroactively authorizing the County Mayor or County Mayor's designee to execute the Form between SoundThinking, Inc., and the County, through the MDPD, providing Ummah with access to the MDPD's ResourceRouter Community Subscription Services data; and to exercise the termination provision contained therein. It is further recommended that the Board authorize the County

Mayor or County Mayor's designee to execute future agreements with SoundThinking for the purpose of sharing data with other public safety organizations who subscribe to SoundThinking's SafetySmart Platform, and to exercise the provisions contained therein.

Scope

The impact of this item is countywide.

Delegation of Authority

The County Mayor or County Mayor's designee is retroactively authorized to execute the Form between the County and SoundThinking, Inc., providing Ummah with access to the MDPD's ResourceRouter Community Subscription Services data, and to exercise the termination provision contained therein. The County Mayor or County Mayor's designee is further authorized to execute future agreements with SoundThinking for the purpose of sharing data with other public safety organizations who subscribe to SoundThinking's SafetySmart Platform and to exercise the provisions contained therein.

Fiscal Impact/Funding Source

The County, through the MDPD, is a current SoundThinking end user. There is no additional charge for SoundThinking's ResourceRouter Community subscription services. As such, this item will not create a negative fiscal impact.

Track Record/Monitor

Assistant Director Christopher J. Carothers, of the MDPD's Investigative Services will track and monitor this item.

Background

SoundThinking offers its ResourceRouter Community subscription services to community organizations, such as Ummah, that provide community violence interventions in communities where SoundThinking's ShotSpotter and/or ResourceRouter are implemented. Wayne E. Rawlins, President of Ummah, is the Project Manager for the County's Anti-Violence Initiative, which includes the Group Violence Intervention and the Walking One Stop initiatives that deliver one-stop victim services to County residents living in neighborhoods affected by gun violence. To further the mission of the County's Anti-Violence Initiative, the MDPD wishes to provide Ummah with access to certain ResourceRouter data so that Ummah may dispatch services to the community in a manner consistent with and complementary to MDPD's police services.

RESOLUTION APPROVING THE TERMS OF AND RETROACTIVELY AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO EXECUTE AN AUTHORIZED ACCESS FORM BETWEEN MIAMI-DADE COUNTY, THROUGH THE MIAMI-DADE POLICE DEPARTMENT ("MDPD"), AND SOUNDTHINKING, INC., PROVIDING UMMAH FUTURES INTERNATIONAL, LLC WITH ACCESS TO MDPD'S RESOURCEROUTER COMMUNITY SUBSCRIPTION SERVICES DATA, AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO EXERCISE THE TERMINATION PROVISION CONTAINED THEREIN; FURTHER AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO EXECUTE FUTURE AGREEMENTS WITH SOUNDTHINKING PROVIDING CERTAIN PUBLIC SAFETY ORGANIZATIONS WITH ACCESS TO MDPD'S SOUNDTHINKING DATA, AND TO EXERCISE THE TERMINATION PROVISION CONTAINED THEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the terms of the Authorized Access Form, attached hereto as Exhibit A and made a part hereof, between SoundThinking, Inc. (SoundThinking), and Miami-Dade County, through the Miami-Dade Police Department (MDPD), for the purpose of providing Ummah Futures International, LLC with access to the MDPD's ResourceRouter Community Subscription Services data, for a term that began upon signature by all parties and expires on the 15th day following notice of termination.

Section 2. Retroactively authorizes the County Mayor or County Mayor’s designee to execute Exhibit A.

Section 3. Authorizes the County Mayor or County Mayor’s designee to exercise the termination provision contained in Exhibit A.

Section 4. Authorizes the County Mayor or County Mayor’s designee to execute future Agreements, in substantially the form attached hereto and labeled Exhibit A, with SoundThinking for the purpose of providing public safety organizations with access to MDPD’s SoundThinking data, and to exercise the termination provision contained therein.
