2022-23 DISTRICT 2 DISCRETIONARY RESERVE

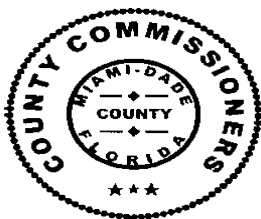
WHEREAS, this Board desires to allocate funds from the FY 2022-23 District 2 Discretionary Reserve in accordance with the attached memorandums,
