**Subject:** Resolution Approving the Plat of Estates at Sunset Filed by The University Baptist Church of Coral Gables, Inc. and CC Homes at Sunset, LLC

---

**Recommendation**

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Estates at Sunset is bounded on the north by SW 72 Street, on the east approximately 150 feet west of SW 72 Court, on the south by SW 76 Street, and on the west by SW 74 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

**Scope**

This plat is located in Commission District 6, which is represented by Commissioner Kevin Marino Cabrera.

**Delegation of Authority**

There are no delegation requirements with this item.

**Fiscal Impact/Funding Source**

There is no fiscal impact to Miami-Dade County with the approval of this plat as all improvements are in place.

**Track Record/Monitor**

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Estates at Sunset T-24719

- Located in Section 35, Township 54 South, Range 40 East.
- Zoning: PAD.
- Proposed Usage: 27 single family residences and a church.
- Number of Parcels: 27.
- This plat meets concurrency.
- This plat was determined to be within feasible distance to public water and public sanitary sewers using the feasible distance requirements in effect prior to the new feasible distance Ordinance No. 22-137. As a condition of this approval, the proposed development is required to connect to public water and public sanitary sewers.

RESOLUTION NO. R-969-23

RESOLUTION APPROVING THE PLAT OF ESTATES AT SUNSET, FILED BY THE UNIVERSITY BAPTIST CHURCH OF CORAL GABLES, INC. AND CC HOMES AT SUNSET, LLC, LOCATED IN THE NORTHWEST 1/4 OF SECTION 35, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 72 STREET, ON THE EAST APPROXIMATELY 150 FEET WEST OF SW 72 COURT, ON THE SOUTH BY SW 76 STREET, AND ON THE WEST BY SW 74 AVENUE)

**WHEREAS**, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

**WHEREAS**, the University Baptist Church of Coral Gables, Inc., a Florida not-for-profit corporation and CC Homes at Sunset, LLC, a Florida limited liability company, have this day presented to this Board a plat of certain lands lying in Miami-Dade County, said plat to be known as “Estates at Sunset,” the same being a replat of Tract “A” of “University Baptist Church”, according to the plat thereof, as recorded in Plat Book 167, at Page 86, lying and being in the Northwest 1/4 of Section 35, Township 54 South, Range 40 East, Miami-Dade County, Florida, and that portion of SW 76th Street lying within the boundaries of the plat vacated by Resolution R-1224-20, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

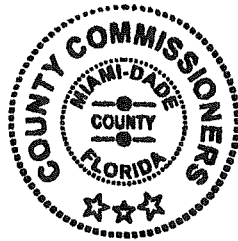
**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.

The foregoing resolution was offered by Commissioner **Raquel A. Regalado** , who moved its adoption. The motion was seconded by Commissioner **Danielle Cohen Higgins** and upon being put to a vote, the vote was as follows:
