Subject: Resolution Retroactively Accepting a Grant Award from The Children's Trust

Recommendation

It is recommended that the Board of County Commissioners (Board) retroactively approve the attached resolution accepting a grant award from The Children's Trust, Contract No. 2414-7600 for \$2,500,000 for the grant period August 15, 2023 through August 14, 2024 and a contract renewal term not to exceed five renewal periods.

Scope

The Children's Trust grant provides funding for 15 Miami-Dade Parks, Recreation and Open Spaces Department (PROS) park sites throughout the County; therefore, the impact is countywide in nature. The 15 County Parks are: Highland Oaks Park, Ojus Park, Oak Grove Park, Little River Park, Gwen Cherry Park, Sidney Wynn Park at Arcola, Dr. Martin Luther King, Jr. Park, Tamiami Park, Kendale Lakes Park, Camp Matecumbe, Ruben Dario Park, JL (Joe) and Enid W. Demps Park, Naranja Park, Live Like Bella Park, and Wilbur B. Bell Park.

Fiscal Impact/Funding Source

The fiscal impact is the receipt of \$2,500,000 of grant funds by the County from the Children's Trust for the grant period ending August 14, 2024. There is no incremental operating impact to the County as a result of obtaining these grants. At the sole discretion of The Children's Trust, these contracts may be renewed, not exceeding five yearly renewal terms, for a potential amount of \$12,500,000 in total grant funds to the County.

Delegation of Authority

The Board authorizes the County Mayor or Mayor's designee to accept and expend funds and execute contracts, amendments, and other documents as required by the grant, upon review and final approval of the County Attorney's Office.

Track Record/Monitor

These grants will be administered by Eric Hansen, Chief of Recreation Programs & Services and Justin Cabrera, Administrative Officer 3.

Background

The Children's Trust and PROS desire to enter into Contract No. 2414-7600 for the first term of a possible five-year term. The programs funded from The Children's Trust grant are Youth Development Programs for children in grades K-5, 6-8, and 9-12 that are inclusionary of children with disabilities in social skills/resilience/risk-reduction for after school programs and summer camps. PROS will serve a minimum of 405 children in grades K-5, 80 youth in grades 6-8, and 80

youths in grades 9-12 in afterschool programs, 195 children in grades K-5, 80 youth in grades 6-8 in full day programs, and 495 children in grades K-5, 100 youth in grades 6-8, and 80 youths in grades 9-12 in summer camps.

No weekly fees will be required for children and youth attending these programs. The grant agreement for execution was received from The Children's Trust in August, therefore, the approval of the grants is retroactive. An adopted resolution was not required by the funding agency for the submittal of the grant application. A copy of the grant contract agreement is on file with the Parks, Recreation and Open Spaces Department and available for inspection upon request.

RESOLUTION RETROACTIVELY APPROVING A GRANT AGREEMENT, CONTRACT NO. 2414-7600, BETWEEN MIAMI DADE COUNTY AND THE CHILDREN'S TRUST IN THE TOTAL AMOUNT OF \$2,500.000.00 IN AFTER-SCHOOL AND SUMMER CAMP GRANT FUNDS FROM THE CHILDREN'S TRUST, AND FURTHER AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO RECEIVE AND EXPEND FUNDS FOR A MAXIMUM OF FIVE RENEWAL TERMS SHOULD THEY BECOME AVAILABLE UNDER THIS PROGRAM, EXECUTE AGREEMENTS AND CERTAIN OTHER DOCUMENTS AS REQUIRED BY THE CHILDREN'S TRUST

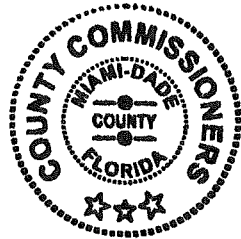
WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively approves a grant agreement, Contract No. 2414-7600, between The Children's Trust and Miami-Dade County in the amount of \$2,500,000.00 for after-school and summer camp programs, authorizing the County Mayor or the County Mayor's designee to execute same for and on behalf of Miami-Dade County, to receive and expend funds for a maximum of five renewal periods, and to execute contracts, agreements, amendments, extensions, renewals, and other documents as required by the Children's Trust. A copy of the grant agreement Contract No. 2414-7600, is on file with the Parks, Recreation and Open Spaces Department and available for inspection upon request.
