Subject: Resolution Approving the Plat of Learning Experience Subdivision Filed by The Learning Experience School, Inc.

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Learning Experience Subdivision is bounded on the north approximately 520 feet south of SW 56 Street, on the east approximately 150 feet west of SW 79 Avenue, on the south by SW 58 Street, and on the west approximately 750 feet east of SW 82 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 6, which is represented by Commissioner Kevin Marino Cabrera.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the county would be approximately \$100.00 annually for the maintenance of new roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Background

Learning Experience Subdivision T-24825

- Located in Section 27, Township 54 South, Range 40 East.
- Zoning: EU-M.
- Proposed Usage: one single family residence.
- Number of Parcels: one.
- This plat meets concurrency.
- This single-family residence was determined to be within feasible distance to public water but not within feasible distance to public sanitary sewers using the feasible distance requirements in effect prior to the new feasible distance Ordinance No. 22-137. The tentative plat was approved prior to the effective date of said Ordinance.
- The proposed development is required to connect to public water.
- The proposed subdivision will be required to install a Type 3 OSTDS to comply with the new OSTDS requirements adopted in Ordinance No. 22-83.

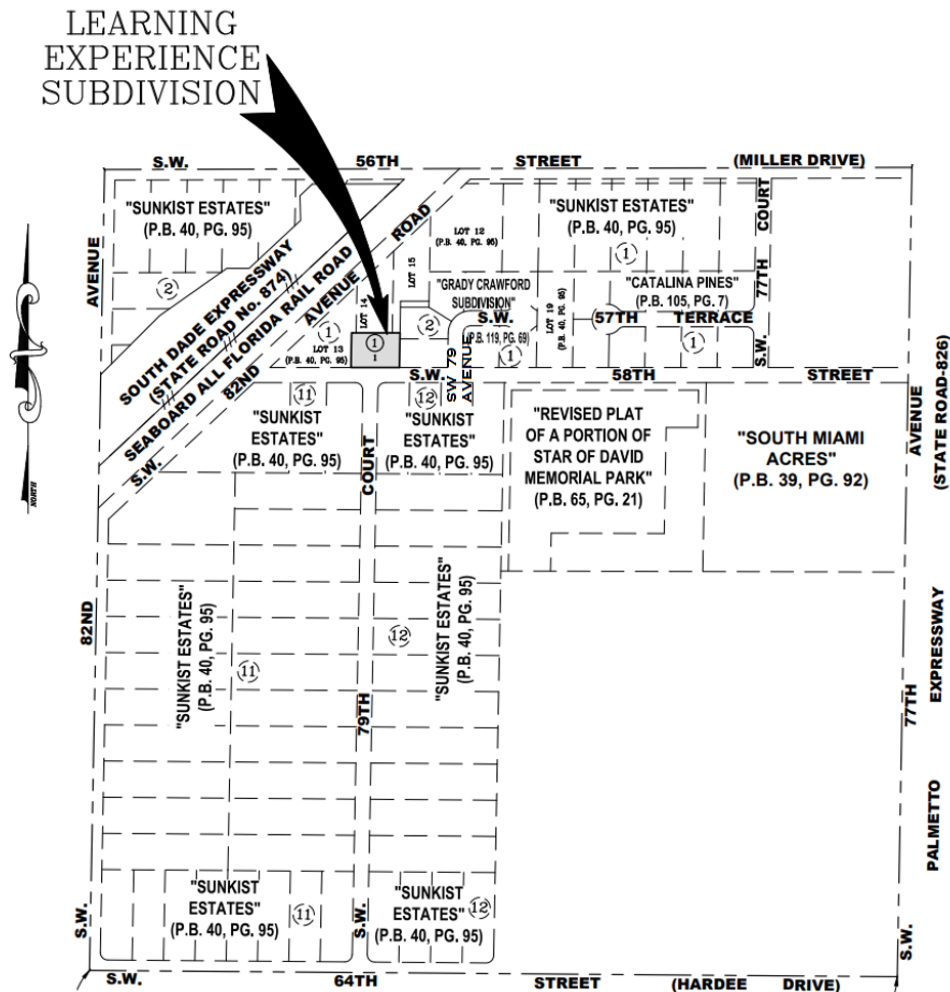

RESOLUTION NO. R-24-24

RESOLUTION APPROVING THE PLAT OF THE LEARNING EXPERIENCE SUBDIVISION, FILED BY LEARNING EXPERIENCE SCHOOL, INC., LOCATED IN THE NORTHEAST 1/4 OF SECTION 27, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH APPROXIMATELY 520 FEET SOUTH OF SW 56 STREET, ON THE EAST APPROXIMATELY 150 FEET WEST OF SW 79 AVENUE, ON THE SOUTH BY SW 58 STREET, AND ON THE WEST APPROXIMATELY 750 FEET EAST OF SW 82 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, The Learning Experience School, Inc., a Florida not for profit corporation, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, said plat to be known as “Learning Experience Subdivision,” the same being a replat of portions of Lots 13, 14, and 15, Block 1, of “Sunkist Estates”, according to the plat thereof, as recorded in Plat Book 40, at Page 95 of the Public Records of Miami-Dade County, Florida, lying and being in the Northeast 1/4 of Section 27, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.

The foregoing resolution was offered by Commissioner **Anthony Rodriguez**, who moved its adoption. The motion was seconded by Commissioner **Oliver G. Gilbert, III** and upon being put to a vote, the vote was as follows:
