Subject: Resolution Approving the Plat of Pita House Filed by REI South Florida, LLC

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Pita House is bounded on the north approximately 140 feet south of SW 219 Street, on the east approximately 110 feet west of SW 123 Avenue, on the south by SW 220 Street, and on the west approximately 460 feet east of SW 124 Avenue.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Full scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 9, which is represented by Commissioner Kionne L. McGhee.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this plat; all improvements are in place.

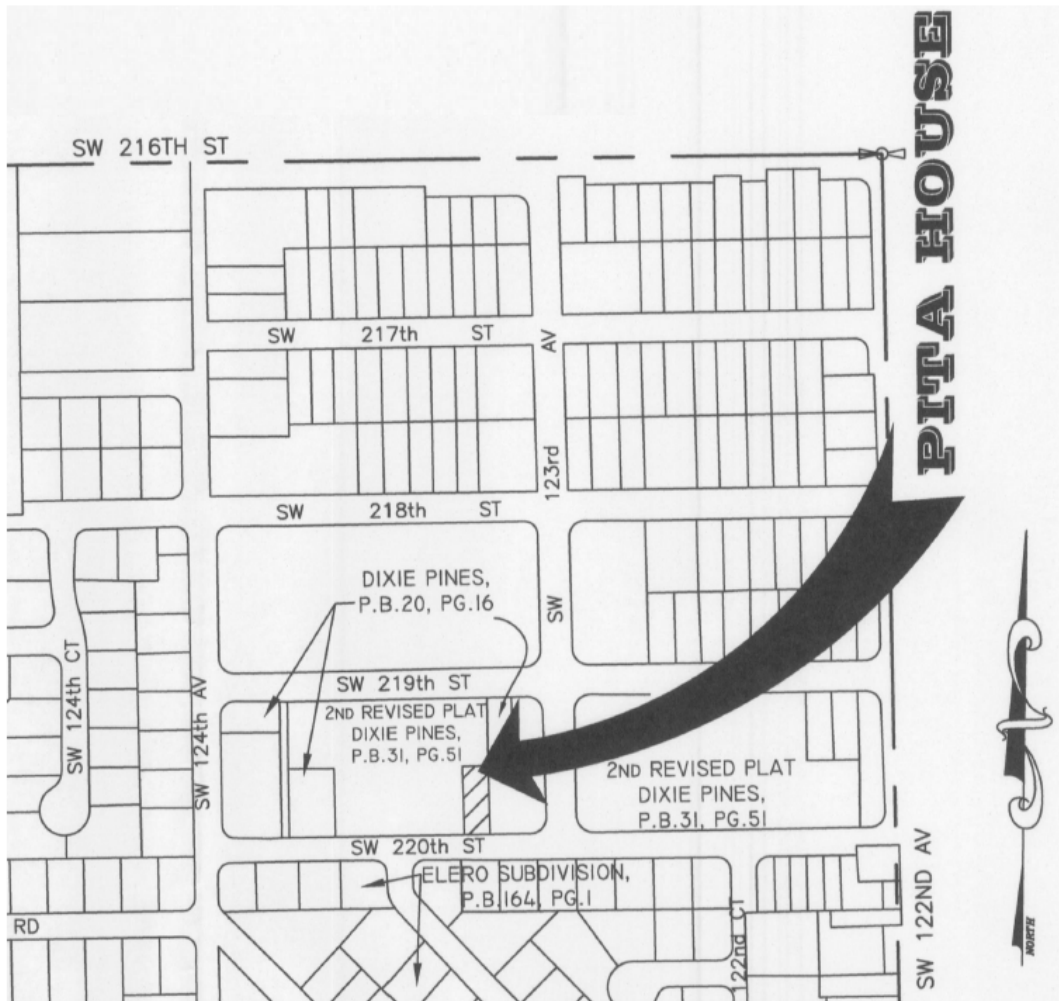

RESOLUTION APPROVING THE PLAT OF PITA HOUSE
FILED BY REI SOUTH FLORIDA LLC, LOCATED IN THE
NORTHWEST 1/4 OF SECTION 13, TOWNSHIP 56 SOUTH,
RANGE 39 EAST (BOUNDED ON THE NORTH
APPROXIMATELY 140 FEET SOUTH OF SW 219 STREET, ON
THE EAST APPROXIMATELY 110 FEET WEST OF SW 123
AVENUE, ON THE SOUTH BY SW 220 STREET, AND ON THE
WEST APPROXIMATELY 460 FEET EAST OF SW 124
AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, REI South Florida, LLC, a Florida limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as “Pita House,” the same being a replat of a portion of Tract 1-A of “2nd Revised Plat of Dixie Pines,” according to the plat thereof, as recorded in Plat Book 31, at Page 51 of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 13, Township 56 South, Range 39 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any

zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.
