RESOLUTION NO. _____ R-55-24

RESOLUTION URGING THE FLORIDA LEGISLATURE TO
APPROPRIATE FUNDING TO FACILITATE THE
CONSTRUCTION OF IMPROVEMENTS TO THE ROLLER
HOCKEY RINK AT THE PALMETTO GOLF COURSE
FACILITY

WHEREAS, a roller hockey rink currently exists at the Palmetto Golf Course facility located at the intersection of SW 152nd Street and U.S. Route 1; and

WHEREAS, the Palmetto Golf Course and the related roller hockey rink are owned and operated by Miami-Dade County (the “County”); and

WHEREAS, the facility is highly utilized by residents and frequented by families and children; and

WHEREAS, roller hockey is a popular sport played across the United States, and in several other countries; and

WHEREAS, encouraging residents to engage in physical activity, such as roller hockey, may result in public health benefits; and

WHEREAS, significant improvements to the roller hockey rink at the Palmetto Golf Course facility are required; and

WHEREAS, such improvements include a metal roof structure, an adjacent building with restrooms and storage space, parking lot reconfiguration, new lighting, a scoreboard, and six fans; and

WHEREAS, this Board wishes to pursue all available funding for the construction of improvements to the roller hockey rink at the Palmetto Golf Course facility,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Urges the Florida Legislature to appropriate funding to facilitate the construction of improvements to the roller hockey rink at the Palmetto Golf Course facility.

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the Governor, the Senate President, the House Speaker, and the Chair and Members of the Miami-Dade State Legislative Delegation.

Section 3. Directs the County’s state lobbyists to advocate for the action described in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2024 State Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Danielle Cohen Higgins. It was offered by Commissioner **Danielle Cohen Higgins** , who moved its adoption. The motion was seconded by Commissioner **Juan Carlos Bermudez** and upon being put to a vote, the vote was as follows:
