Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for Emilio Enriquez is bounded on the north approximately 300 feet south of SW 334 Street, on the east approximately 810 feet west of SW 194 Avenue, on the south by SW 336 Street and on the west approximately 290 feet east of SW 197 Avenue.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

This waiver of plat is located in Commission District 9, which is represented by Commissioner Kionne L. McGhee.

- As a condition of this waiver of plat approval, the proposed single-family residence will be required to provide an on-site domestic well and an onsite sewage treatment and disposal system (OSTDS) for this site.
- The proposed single-family residence will be required to install a Type 3 OSTDS to comply the new OSTDS requirements adopted in Ordinance No. 22-83.


