Subject: Recommendation for Ratification of an Emergency Contract for the Repair of the Vacuum Pressure Swing Adsorption System at the Central District Wastewater Treatment Plant

Summary

This emergency purchase allows for repairs needed at the Central District Wastewater Treatment Plant, managed by the Water and Sewer Department (WASD), to ensure the reliability of the equipment used for the treatment of wastewater for the protection of life, health, and safety of County residents, visitors, and the ecosystem. The contract provides technical support, material, parts, and equipment to inspect, troubleshoot, and repair various vacuum pressure swing adsorption (VPSA) systems that produce pure oxygen for the treatment of wastewater. Pure oxygen enables the growth of aerobic bacteria in the activated sludge treatment process to treat organic contaminants and reduce biochemical oxygen demand. Harsh conditions and extreme humidity has led to failure of the VPSA system components and equipment (sieves, motors, blowers, and other related equipment), which now must be replaced. This emergency is to replace the equipment and make additional, necessary repairs to associated appurtenances.

The failure of the VPSA system at the Central District Wastewater Treatment Plant would create a shortage of oxygen production for the biological wastewater treatment process. This emergency contract was required to comply with the permit issued by the Florida Department of Environmental Protection (FDEP), which requires WASD to operate, control, and maintain the treatment facility to achieve compliance, including the operation of backup or auxiliary facilities. Not maintaining reliability and redundancy of the oxygen producing systems would be a violation of the FDEP permit. In addition, failure to provide adequate biological treatment will result in releasing partially treated wastewater to our waterways, creating a threat to the health and safety of our residents and ecosystem.

Recommendation

It is recommended that the Board of County Commissioners (Board) ratify an emergency contract award, *Contract No. WASD0000267071, Repair of Vacuum Pressure Swing Adsorption System*, to AirSep Corporation (AirSep) for WASD in the amount of \$4,000,000 for a seven-month term. AirSep is the sole source provider of this oxygen producing equipment.

Background

On January 23, 2024, WASD declared an emergency for the immediate repair of the VPSA oxygen generating system, which is manufactured by AirSep, at the Central District Wastewater Treatment Plant (Virginia Key). The VPSA oxygen generating system uses compressed air, passed through adsorbent materials at different pressures to separate oxygen from other gases, to produce oxygen. The oxygen generator uses in its adsorber vessels an active material called molecular sieves to separate compressed air into oxygen and other gases. There are special characteristics and properties of the molecular sieve that are chosen for each project. The sieve is manufactured for each VPSA plant per their specifications and has a unique part number that can only be supplied from AirSep.

This emergency contract will provide troubleshooting and replacement of molecular sieves, motor(s), pump(s), valves, programmable logic controller and instrumentation with repairs and additional spare motors and pumps to ensure redundancy of the VPSAs.

Competition was not practicable due to the proprietary nature of the equipment and the urgent need to acquire these services to ensure the protection of the life, health, and safety of County residents. Accordingly, it is in the County's best interest to ratify this emergency contract award for the provision of technical support, parts, and equipment to inspect and repair waste treatment equipment for WASD.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The fiscal impact for the emergency contract is \$4,000,000 for the seven-month term, which expires on August 31, 2024.

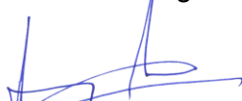

RESOLUTION RATIFYING EMERGENCY CONTRACT NO. WASD0000267071 WITH AIRSEP CORPORATION FOR REPAIR OF THE VACUUM PRESSURE SWING ADSORPTION SYSTEM AT THE MIAMI-DADE WATER AND SEWER DEPARTMENT'S CENTRAL DISTRICT WASTEWATER TREATMENT PLANT IN AN AMOUNT NOT TO EXCEED \$4,000,000.00; AND AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO EXERCISE ALL PROVISIONS OF THE CONTRACT, INCLUDING ANY CANCELLATION OR EXTENSION PROVISIONS, PURSUANT TO SECTION 2-8.1 OF THE COUNTY CODE AND IMPLEMENTING ORDER 3-38

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying County Mayor's memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. This Board finds it is in the best interest of Miami-Dade County to ratify an emergency contract, Contract No. WASD0000267071, with AirSep Corporation, for Repair of Vacuum Pressure Swing Adsorption System at the Miami-Dade Water and Sewer Department's Central District Wastewater Treatment Plant in an amount not to exceed \$4,000,000.00.
