RESOLUTION APPROVING THE CITY OF HIALEAH'S
CODESIGNATION OF THAT PORTION OF WEST 60TH
STREET FROM PALM AVENUE TO WEST 2ND AVENUE AS
"RAYMOND R. ROBINSON STREET"

WHEREAS, the Mayor and the City Council of the City of Hialeah passed Resolution No. 2024-004 on January 9, 2024, which codesignated that portion of West 60th Street from Palm Avenue to West 2nd Avenue as "Raymond R. Robinson Street" in memory of Raymond R. Robinson ("Robinson"); and

WHEREAS, beginning with his appointment in 1976, Robinson faithfully served the City of Hialeah as a Council Member for fourteen years; and

WHEREAS, a copy of Resolution No. 2024-004 is attached hereto and incorporated by reference; and

WHEREAS, that portion of West 60th Street from Palm Avenue to West 2nd Avenue is a city road located in the City of Hialeah; and

WHEREAS, this codesignation is located in County Commission District 13; and

WHEREAS, the City of Hialeah would like for the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this Board would also like to honor Robinson by approving the City of Hialeah's codesignation of that portion of West 60th Street from Palm Avenue to West 2nd Avenue as "Raymond R. Robinson Street,"

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Hialeah’s codesignation of that portion of West 60th Street from Palm Avenue to West 2nd Avenue as “Raymond R. Robinson Street.”

Section 2. Directs the Clerk of the Board to send certified copies of this resolution to the Mayor and City Council of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resource Department, the City of Hialeah Police Department, and the City of Hialeah Fire Department.

The Prime Sponsor of the foregoing resolution is Senator René García. It was offered by Commissioner **Danielle Cohen Higgins**, who moved its adoption. The motion was seconded by Commissioner **Anthony Rodriguez** and upon being put to a vote, the vote was as follows:

RESOLUTION NO. 2024-004

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, DESIGNATING WEST 60TH STREET FROM PALM AVENUE TO WEST 2ND AVENUE AS "RAYMOND R. ROBINSON STREET", WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY; PROVIDING FOR TRANSMITTAL OF THE RESOLUTION TO THE COUNTY, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Raymond R. Robinson was born in Miami, Florida, moved to Hialeah, and graduated from Hialeah High School in 1959; and

WHEREAS, in 1975, Mr. Robinson was a candidate for Council Member of the City of Hialeah and came in fifth losing the election. Mr. Robinson was appointed to City Council Member in 1976 to fill a vacancy in the City Council per the City Charter; and

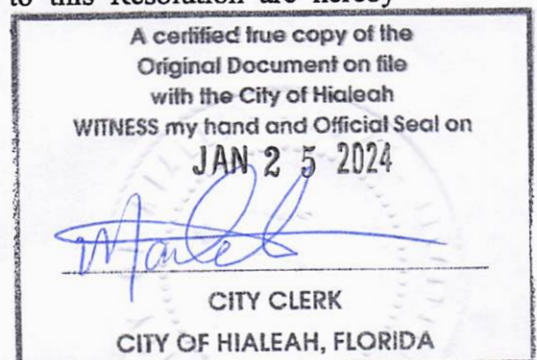
WHEREAS, Raymond R. Robinson faithfully served the City of Hialeah as a Council member for fourteen (14) years; and

WHEREAS, that portion of West 60th Street from Palm Avenue to West 2nd Avenue is a street located in the City of Hialeah and is classified as a City or municipal street with the State Road System; and

WHEREAS, at its November 9, 2023 meeting, the City of Hialeah Historic Preservation Board passed and adopted Resolution No. 2023-005 recommending this street designation.

THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The recitals contained in the preamble to this Resolution are hereby incorporated and adopted by reference as if fully set forth herein.

Section 2: The City Council hereby re-names that portion of West 60th Street from Palm Avenue to West 2nd Avenue is designated “Raymond R. Robinson Way”, with the cost of signage to be paid by the City, in recognition of Raymond R. Robinson.

Section 3: The Mayor and City Council direct the City Clerk to transmit a certified copy of this Resolution to the Mayor of Miami-Dade County, the Miami-Dade County Transportation /Public Works Director, and the Clerk to the Miami-Dade County Board of County Commissioners.

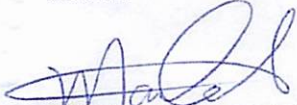

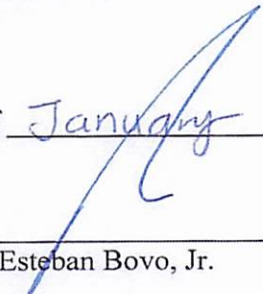

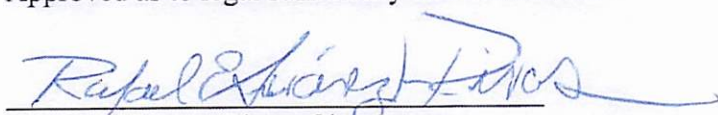
