RESOLUTION NO. _____ R-419-24

RESOLUTION DECLARING JUNE 7, 2024 AS MIAMI-DADE YOUTH GOVERNANCE DAY; DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO COORDINATE WITH THE MIAMI-DADE COUNTY YOUTH COMMISSION TO PARTICIPATE IN MIAMI-DADE YOUTH GOVERNANCE DAY; URGING MUNICIPALITIES IN MIAMI-DADE COUNTY TO PARTICIPATE IN MIAMI-DADE YOUTH GOVERNANCE DAY

WHEREAS, this Board has long recognized the unique voice and opinion of the youth in Miami-Dade County and the important role that they serve in our community's future; and

WHEREAS, in 2010, this Board enacted Ordinance No. 10-05, which is codified at Article CXXXIV, section 2-2060 *et seq.* of the Code of Miami-Dade County (the "Code"), establishing the Miami-Dade County Youth Commission ("Youth Commission"), an advisory board on matters affecting the youth and teen population of Miami-Dade County; and

WHEREAS, the Youth Commission is composed of 27 high school students and serves as a vehicle for them to learn about government, to participate in the process of County government, and to represent and articulate the needs of youth in the County; and

WHEREAS, since its inception, and as evidenced each year through its impressive presentation at the annual joint meeting held with this Board, the Youth Commission has been actively engaged in pursuing its purpose and mission; and

WHEREAS, this year, the Youth Commission seeks to coordinate with Virtutem Populo, a student-led 501(c)(3) nonprofit organization dedicated to promoting civic engagement and community involvement among youth in the county, to carry out the 2024 Miami-Dade Youth Governance Day initiative; and

WHEREAS, the initiative is set to take place on June 7, 2024; and

WHEREAS, the goal is for a select group of high school students to act as “Mayor for the Day” in Miami-Dade County, as well as each of the 34 municipal governments within the County; and

WHEREAS, as “Mayor for the Day,” these youth will obtain firsthand experience of being a public servant and providing essential services to our community; and

WHEREAS, this Board wishes to support the work of the Youth Commission and promote the County’s participation in the 2024 Miami-Dade Youth Governance Day, as well as that of the municipalities,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Declares June 7, 2024 as Miami-Dade Youth Governance Day.

Section 2. Directs the County Mayor or County Mayor’s designee to coordinate with the Miami-Dade County Youth Commission to participate in Miami-Dade Youth Governance Day.

Section 3. Urges municipalities in Miami-Dade County to participate in Miami-Dade Youth Governance Day.

Section 4. Directs the Clerk of the Board to transmit certified copies of this resolution to the Mayors and City Councils or City Commissioners of all of the municipalities within Miami-Dade County.

The Prime Sponsor of the foregoing resolution is Chairman Oliver G. Gilbert, III. It was offered by Commissioner **Danielle Cohen Higgins**, who moved its adoption. The motion was seconded by Commissioner **Anthony Rodriguez** and upon being put to a vote, the vote was as follows:
