Subject: Resolution Approving the Waiver of Plat of HL Transpacific, LLC filed by HL Transpacific, LLC

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for HL Transpacific, LLC is bounded on the north by SW 64 Street, on the east approximately 75 feet west of SW 75 Avenue, on the south approximately 650 feet north of SW 67 Street and on the west by SW 76 Avenue.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 6, which is represented by Commissioner Kevin Marino Cabrera.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

There is no fiscal impact to Miami-Dade County with the approval of this waiver of plat as all improvements are in place.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Background

- HL Transpacific, LLC (D-21508)
- Located in Section 26, Township 54 South, Range 40 East.
- Zoning: EU-1.
- Proposed usage: Two single family residences.
- Number of parcels: Two.
- This waiver of plat meets concurrency.
- These two single-family residences were determined to be within feasible distance to public water but not within feasible distance to public sanitary sewers using the feasible distance requirements in effect prior to the new feasible distance Ordinance No. 22-137. The waiver of plat was recommended for approval prior to the effective date of said ordinance.
- The proposed development is required to connect to public water.
- The proposed subdivision will be required to install a Type 3 OSTDS to comply with the new OSTDS requirements adopted in Ordinance No. 22-83.

Developer's Obligation

None, all improvements are in place.

RESOLUTION APPROVING THE WAIVER OF PLAT OF HL TRANSPACIFIC, LLC, D-21508, FILED BY HL TRANSPACIFIC, LLC, LOCATED IN THE SOUTHWEST 1/4 OF SECTION 26, TOWNSHIP 54 SOUTH, RANGE 40 EAST (BOUNDED ON THE NORTH BY SW 64 STREET, ON THE EAST APPROXIMATELY 75 FEET WEST OF SW 75 AVENUE, ON THE SOUTH APPROXIMATELY 650 FEET NORTH OF SW 67 STREET AND ON THE WEST BY SW 76 AVENUE)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, HL Transpacific, LLC, a Florida limited liability company, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of land lying and being in the Southwest 1/4 of Section 26, Township 54 South, Range 40 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.
