RESOLUTION DIRECTING THE COUNTY MAYOR OR  
COUNTY MAYOR'S DESIGNEE TO TAKE THE NECESSARY  
STEPS TO ESTABLISH A POOL FOR THE OUTSOURCING OF  
NEEDED REPAIR WORK TO SIDEWALKS ON MIAMI-DADE  
COUNTY MAINTAINED RIGHTS-OF-WAY

**WHEREAS**, sidewalks are an integral means of passage for pedestrians throughout  
Miami-Dade County; and

**WHEREAS**, ensuring that sidewalks are quickly repaired enhances safety and overall  
quality of life for Miami-Dade County residents and visitors; and

**WHEREAS**, there exists a backlog of sidewalk repairs due to the limited availability of  
County in-house repair personnel; and

**WHEREAS**, establishing a pool of qualified construction firms would facilitate the  
expeditious repairs of sidewalks within Miami-Dade County,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY  
COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Directs the County Mayor or County Mayor's designee to take the necessary  
steps to establish a pool for the outsourcing of needed repair work to sidewalks on Miami-Dade  
County maintained rights-of-way.

**Section 2.** Directs the County Mayor or County Mayor's designee within 30 days of  
the effective date of this resolution to prepare a report regarding the directives in section 1 above  
and to place the completed report on an agenda of this Board without committee review pursuant  
to rule 5.06(j) of the Board's Rules of Procedure.

The Prime Sponsor of the foregoing resolution is Chairman Anthony Rodríguez. It was offered by Commissioner **Kevin Marino Cabrera** , who moved its adoption. The motion was seconded by Commissioner **Kionne L. McGhee** and upon being put to a vote, the vote was as follows:
