Subject: Resolution Approving the Waiver of Plat of JN Commonwealth, Inc. Filed by JN Commonwealth, Inc.

Recommendation

The following waiver of plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This waiver of plat for JN Commonwealth, Inc. is bounded on the north by NW 80 Street, on the east by NW 13 Avenue, on the south approximately 400 feet north of NW 79 Street and on the west by approximately 210 feet east of NW 13 Court.

The Miami-Dade County Plat Committee recommends approval of this waiver of plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

Legal description of the boundaries of the land are on file with the Department of Regulatory and Economic Resources.

Scope

This waiver of plat is located in Commission District 2, which is represented by Commissioner Marleine Bastien.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the county would be approximately \$100.00 annually for new roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

Background

- JN Commonwealth, Inc. (D-24594)
- Located in Section 11, Township 53 South, Range 41 East.
- Zoning: RU-1.
- Proposed usage: One single family residence.
- Number of parcels: One.
- This waiver of plat meets concurrency.
- This single-family residence was determined to be within feasible distance to public water but not within feasible distance to public sanitary sewers using the feasible distance requirements in effect prior to the new feasible distance Ordinance No. 2-137. The waiver of plat was approved prior to the effective date of said ordinance.
- The proposed single-family residence is required to connect to the public water supply system and will be required to install a Type 2 OSTDS to comply with the new OSTDS requirements adopted in Ordinance No. 22-83.

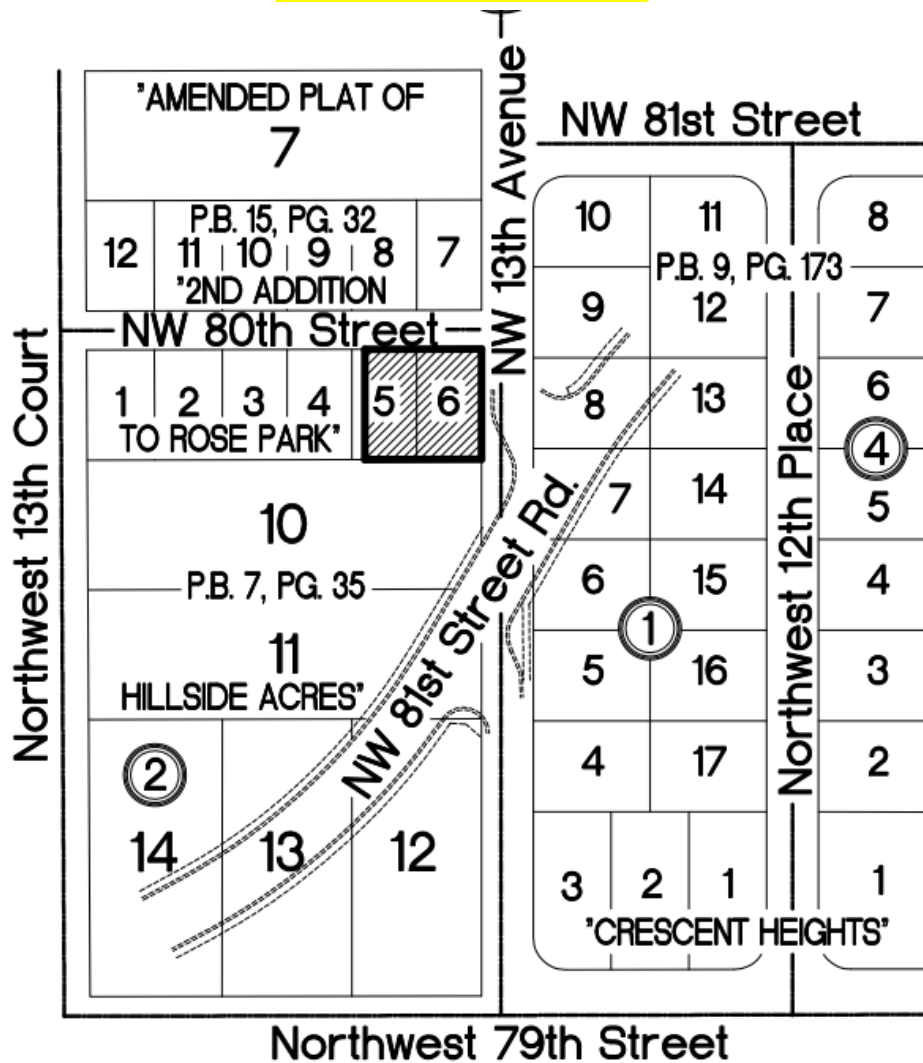

RESOLUTION APPROVING THE WAIVER OF PLAT OF JN COMMONWEALTH, INC., D-24594, FILED BY JN COMMONWEALTH, INC., LOCATED IN THE NORTHWEST 1/4 OF SECTION 11, TOWNSHIP 53 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY NW 80 STREET, ON THE EAST BY NW 13 AVENUE, ON THE SOUTH APPROXIMATELY 400 FEET NORTH OF NW 79 STREET AND ON THE WEST BY APPROXIMATELY 210 FEET EAST OF NW 13 COURT)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, JN Commonwealth, Inc., a Florida corporation, has this day presented to this Board a waiver of plat of certain lands lying in Miami-Dade County, Florida, said waiver of plat of the property legally described as a portion of Lot 5, and all of Lot 6 of "Second Addition to Rose Park," according to the plat thereof, as recorded in Plat Book 15, at Page 32, of the Public Records of Miami-Dade County, Florida, lying and being in the Northwest 1/4 of Section 11, Township 53 South, Range 41 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said waiver of plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said waiver of plat is hereby approved; that the property has been found to be in compliance with chapter 28, Subdivisions, of the Miami-Dade County Code; that approval of this waiver of plat is not a waiver

of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this waiver of plat conforms to those requirements.
