2024-25 DISTRICT 13 DISCRETIONARY RESERVE

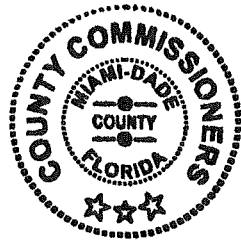
WHEREAS, this Board desires to allocate funds from the FY 2024-25 District 13 Discretionary Reserve in accordance with the attached memorandum,
