RESOLUTION JOINING THE CITY OF MIAMI GARDENS IN
URGING THE FLORIDA LEGISLATURE TO CODESIGNATE
NW 47TH AVENUE FROM NW 199TH STREET TO NW 207TH
DRIVE AS “CONGRESSWOMAN FREDERICA S. WILSON
BOULEVARD”; APPROVING SUCH CODESIGNATION

WHEREAS, on November 13, 2024, the City Council of the City of Miami Gardens passed a resolution, a copy of which is attached hereto and incorporated by reference, urging the Florida Legislature to codesignate NW 47th Avenue from NW 199th Street to NW 207th Drive as “Congresswoman Frederica S. Wilson Boulevard” and requesting the support of this Board for such purpose; and

WHEREAS, Congresswoman Frederica S. Wilson has served the community with distinction over the years, advocating tirelessly for the betterment of her constituents and ensuring that the voices of the underserved are heard; and

WHEREAS, her commitment to education, economic development, public safety, and social justice has positively impacted countless individuals and families across all of Miami-Dade County; and

WHEREAS, Congresswoman Wilson’s accomplishments during her many years of public service include:

- Education Advocacy: Congresswoman Wilson has been a fierce advocate for education, founding the 5000 Role Models of Excellence Project, a dropout prevention and mentoring program for at-risk youth, which has been instrumental

in changing the lives of thousands of young men by providing mentorship, scholarships, and positive guidance;

- Support for Veterans: Congresswoman Wilson has worked diligently to support veterans, advocating for improved healthcare services, benefits, and support programs for those who have served the country; and
- Job Creation and Economic Development: Congresswoman Wilson has worked to create job opportunities and foster economic development in her district, focusing on empowering small businesses and ensuring that underrepresented communities have access to economic resources; and

WHEREAS, this Board would also like to recognize Congresswoman Wilson for her extensive service and contributions to the community as a dedicated public servant by joining the City of Miami Gardens in urging the Florida Legislature to codesignate NW 47th Avenue from NW 199th Street to NW 207th Drive as “Congresswoman Frederica S. Wilson Boulevard”; and

WHEREAS, because NW 47th Avenue is a state road, the Florida Legislature would be required to codesignate this road; and

WHEREAS, section 334.071, Florida Statutes, provides that the erection of markers for a state road designation shall be contingent upon the appropriate city or county commission passing a resolution in support of the particular honorary designation; and

WHEREAS, that portion of NW 47th Avenue from NW 199th Street to NW 207th Drive is a state road located partially in the City of Miami Gardens and partially in unincorporated Miami-Dade County; and

WHEREAS, this codesignation is located in County Commission District 1,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Joins the City of Miami Gardens in urging the Florida Legislature to codesignate NW 47th Avenue from NW 199th Street to NW 207th Drive as “Congresswoman Frederica S. Wilson Boulevard”.

Section 2. Approves such codesignation.

Section 3. Directs the Clerk of the Board to send certified copies of this Resolution to the Governor, Senate President, House Speaker, the Chair and Members of the Miami-Dade State Legislative Delegation, the City Council of the City of Miami Gardens, the Secretary of the Florida Department of Transportation, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resources Department, the City of Miami Gardens Police Department, the Miami-Dade Police Department and the Miami-Dade Fire-Rescue Department.

Section 4. Directs the County’s state lobbyists to advocate for the legislation set forth in section 1 above, and authorizes and directs the Office of Intergovernmental Affairs to amend the 2025 State Legislative Package to include this item.

The Prime Sponsor of the foregoing resolution is Commissioner Oliver G. Gilbert, III. It was offered by Commissioner **Kevin Marino Cabrera** , who moved its adoption. The motion was seconded by Commissioner **Kionne L. McGhee** and upon being put to a vote, the vote was as follows:

Staff Summary

Councilman Leon is recommending that the City Council urge the Florida House of Representatives and the Senate to co-designation of NW 47th Avenue, from NW 199th Street to NW 207th Drive, as Congresswoman Frederica S. Wilson Boulevard in recognition of her extensive service and contributions to the community as a dedicated public servant.

Congresswoman Frederica S. Wilson has served the community with distinction over the years, advocating tirelessly for the betterment of her constituents and ensuring that the voices of the underserved are heard. Congresswoman Wilson's career in public service began in the Florida Legislature, where she served as a member of the Florida House of Representatives from 1998 to 2002 and then as a member of the Florida Senate from 2002 to 2010. During her tenure in the Florida Senate, she held the position of Senate Minority Leader Pro Tempore.

In 2011, Congresswoman Wilson was elected to the U.S. House of Representatives, where she continues to serve as a strong advocate for her community. Her commitment to education, economic development, public safety, and social justice has positively impacted countless individuals and families.

Throughout her years in public service, Congresswoman Wilson has achieved numerous milestones, including:

Wilson Boulevard. The City Council further requests support from Miami-Dade County Board of County Commissioners through District 1 Office for this purpose.

Section 3: EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
