2024-25 DISTRICT 6 DISCRETIONARY RESERVE

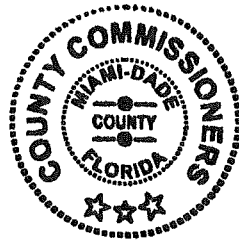
WHEREAS, this Board desires to allocate funds from the FY 2024-25 District 6 Discretionary Reserve in accordance with the attached memorandums,
