2024-25 DISTRICT 13 CBO DISCRETIONARY RESERVE

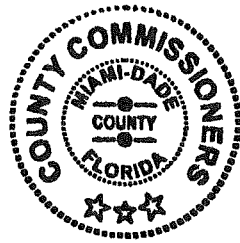
WHEREAS, this Board desires to allocate funds from the FY 2024-25 CBO District 13 Discretionary Reserve in accordance with the attached memorandums,
