RESOLUTION DESIGNATING CORNELIUS SHIVER AS
CHAIRMAN OF THE NARANJA LAKES COMMUNITY
REDEVELOPMENT AGENCY IN ACCORDANCE WITH
SECTION 163.356, FLORIDA STATUTES AND SECTION 2-
1470 OF THE CODE OF MIAMI-DADE COUNTY, FLORIDA

WHEREAS, at the February 19, 2025, Board of County Commissioners meeting, a motion was made to designate Cornelius Shiver as chairman of the Naranja Lakes Community Redevelopment Agency in accordance with section 163.356, Florida Statutes, and section 2-1470 of the County Code,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:
