RESOLUTION DIRECTING THE COUNTY MAYOR OR
COUNTY MAYOR'S DESIGNEE TO TAKE THE NECESSARY
STEPS TO ESTABLISH A POOL FOR THE OUTSOURCING OF
NEEDED REPAIR AND MAINTENANCE WORK TO ROADS
ON MIAMI-DADE COUNTY MAINTAINED RIGHTS-OF-WAY

WHEREAS, ensuring that roads are adequately maintained and quickly repaired enhances
safety and overall quality of life for Miami-Dade County residents and visitors; and

WHEREAS, there exists a backlog of road repairs due to the limited availability of County
in-house repair personnel; and

WHEREAS, establishing a pool of qualified construction firms would facilitate the
expeditious repairs of roads within Miami-Dade County; and

WHEREAS, on December 3, 2024, the County adopted Resolution No. R-1100-24 to
establish a similar pool which would facilitate the expeditious repairs of sidewalks within Miami-
Dade County,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

Section 1. Directs the County Mayor or County Mayor's designee to take the necessary
steps to establish a pool for the outsourcing of needed repair work to roads on Miami-Dade County
maintained rights-of way.

Section 2. Directs the County Mayor or County Mayor's designee within 30 days of
the effective date of this resolution to prepare a report regarding the directives in section 1 above
and to place the completed report on an agenda of this Board without committee review pursuant
to rule 5.06(j) of the Board's Rules of Procedure.

The Prime Sponsor of the foregoing resolution is Commissioner Roberto J. Gonzalez. It was offered by Commissioner **Danielle Cohen Higgins** , who moved its adoption. The motion was seconded by Commissioner **Roberto J. Gonzalez** and upon being put to a vote, the vote was as follows:
