RESOLUTION NO. R-318-25

RESOLUTION ADOPTING AS BOARD POLICY THAT, IF THE 2026 NASCAR CHAMPIONSHIP WEEKEND IS HELD IN MIAMI-DADE COUNTY IN NOVEMBER 2026, THE BOARD PROVIDE FUNDING SUPPORT FOR THE EVENT IN FISCAL YEAR 2026-27 SUBJECT TO THE BOARD'S BUDGET AND APPROPRIATION, CONSISTING OF (A) CASH SUPPORT FROM LEGALLY AVAILABLE TOURIST DEVELOPMENT TAXES OR CONVENTION DEVELOPMENT TAXES AND (B) IN-KIND SERVICES FROM COUNTY DEPARTMENTS; AND DESIGNATING VICE CHAIRMAN MCGHEE AS A REPRESENTATIVE

WHEREAS, at the March 18, 2025 Board of County Commissioner meeting, a motion was made to adopt as Board policy that, if the 2026 NASCAR Championship Weekend is held in Miami-Dade County in November 2026, the Board provide funding support for the event in Fiscal Year 2026-27 subject to the Board's budget and appropriation, consisting of (a) cash support from legally available tourist development taxes or convention development taxes and (b) in-kind services from County departments and designates Vice Chairman McGhee as a representative,
