Executive Summary

This item retroactively approves the Miami-Dade County Parks, Recreation and Open Spaces Department's (PROS) submission of a grant application to the Florida Inland Navigation District (FIND) 2025 Waterways Assistance Program (WAP). The grant funded project includes the construction of canoe and kayak launch sites at four PROS marinas.

Recommendation

It is recommended that the Board retroactively approves the submission of a grant application (Attachment A) for the Florida Inland Navigation District 2025 Waterways Assistance Program project. It is further recommended that the Board authorizes the County Mayor or County Mayor's designee to receive and expend funds and execute grant agreements upon review and final approval of the County Attorney's Office.

Scope

Pelican Harbor Marina is located in County Commission District 3, which is represented by Commissioner Keon Hardemon; Matheson Hammock Marina is located in County Commission District 7, which is represented by Commissioner Raquel A. Regalado; Black Point Marina is located in County Commission District 8, which is represented by Commissioner Danielle Cohen Higgins; and Herbert Hoover Marina at Homestead Bayfront Park is located in County Commission District 9, which is represented by Vice Chairman Kionne L. McGhee.

Fiscal Impact/Funding Source

The County's estimated project cost is \$3,644,896.00 for the construction of canoe and kayak launch sites at the four County Marinas. FIND will provide \$1,550,842.00 in grant funding, PROS will provide \$2,094,054.00 in funding from the Coastal Park and Marina Improvement Trust Fund (CPME) consisting of match funding of \$1,550,842.00 and \$543,212.00 of costs not eligible under FIND regulations.

Track Record/Monitor

If awarded, the grant will be administered by PROS' Grants Supervisor, Dorothy Mills-Mayers.

Delegation of Authority

This item authorizes the County Mayor or County Mayor's designee to execute grant award agreements, amendments and other documents the grant requires, following approval by the County Attorney's Office as to legal sufficiency; provided however that the County Mayor or Mayor's designee are only

delegated the authority to execute amendments that do not have an additional fiscal impact on the County and that otherwise are for projects eligible under the FIND 2025 Waterway Assistance Program. The Board authorizes the County Mayor or Mayor's designee to receive and expend all monies for the purposes described in the funding request for and on behalf of Miami-Dade County, Florida.

Background

The project will consist of the construction of canoe and kayak launch sites, with 20ft. x 20ft. floating docks, concrete ramps, gangway connecting launch platforms to shore along with conventional piers and separated from boat traffic and will adhere to the Americans with Disabilities Act (ADA) accessibility guidelines. The FIND Waterways Assistance Program is a grant initiative established by the Florida Legislature in partnership with FIND. The goal of WAP is to enhance public access to the Atlantic Intracoastal Waterway and related waterways within FIND. Authorized under Section 374.976 of the Florida Statutes and governed by Chapter 66B-2 of the Florida Administrative Code, WAP serves local governmental agencies, including municipalities, counties, port authorities, and special taxing districts across the twelve (12) counties in FIND.

The application was due March 28, 2025 and was submitted by PROS on March 27, 2025. There was insufficient time from the opportunity announcement to the grant deadline to obtain a resolution, and an adopted resolution is required by the funding agency for the application submittal. If awarded, the prioritized project will be programmed into the 2025-2026 Fiscal Year.

RESOLUTION RETROACTIVELY APPROVING THE SUBMITTAL OF A GRANT APPLICATION TO THE FLORIDA INLAND NAVIGATION DISTRICT (FIND) 2025 WATERWAYS ASSISTANCE PROGRAM FOR \$1,550,842.00 IN FIND FUNDING AND \$2,094,054.00 IN COUNTY COASTAL PARK AND MARINA ENTERPRISE FUNDING FOR CANOE AND KAYAK LAUNCH SITES AT FOUR MIAMI-DADE COUNTY MARINAS: BLACK POINT MARINA, HERBERT HOOVER MARINA AT HOMESTEAD BAYFRONT PARK, MATHESON HAMMOCK MARINA, AND PELICAN HARBOR MARINA, AND FURTHER AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO ACCEPT AND EXPEND FUNDS AND EXECUTE CONTRACTS, AMENDMENTS, AND OTHER DOCUMENTS AS REQUIRED BY THE AGREEMENT

WHEREAS, this Board desires to accomplish the purpose outlined in the accompanying memorandum, a copy of which is incorporated herein by reference, and

WHEREAS, Miami-Dade County is interested in carrying out the following described project for the enjoyment of the citizenry of Miami-Dade County and the State of Florida:

Project Title: Miami-Dade County Marinas and Park Canoe and Kayak Launch Sites-Phase II

Total Estimated Cost: \$3,644,896.00

Brief Description of Project: This project includes the construction of canoe and kayak launch sites that will be constructed to design criteria's which may include standardized 20ft. x 20ft. floating docks, concrete ramps, gangway connecting launch platform to shore, aluminum boarding handles, aluminum grab and launch rails, along with conventional piers and separated from boat traffic and will adhere to the Americans with Disabilities Act (ADA) accessibility guidelines. .

AND, Florida Inland Navigation District financial assistance is required for the program mentioned above,

NOW THEREFORE, be it resolved by the Board of County Commissioners of Miami-Dade County, Florida, that the project described above be authorized,

NOW THEREFORE, be it resolved by the Board of County Commissioners of Miami-Dade County, Florida, that this Board authorizes the submittal of a grant application (Attachment A) to the Florida Inland Navigation District (FIND) 2025 Waterways Assistance Program (WAP) for \$1,550,842.00 for Miami-Dade County Marinas and Park Canoe and Kayak Launch Sites-Phase II. The County will provide up to \$1,550,842.00 in match dollars from the Coastal Park and Marina Improvement Trust Fund (CPME) \$543,212.00 is the amount of funding needed for project completion, which includes all cost not eligible under FIND regulations.

AND, be it further resolved that Miami-Dade County shall make application to the Florida Inland Navigation District in the amount of up to 50% of the FIND actual cost in behalf of Miami-Dade County,

AND, be it further resolved by Miami-Dade County that it certifies to the following:

1. That it will accept the terms and conditions set forth in FIND Rule 66B-2 F.A.C. and which will be a part of the Project Agreement for any assistance awarded under the attached proposal.
2. That it is in complete accord with the attached proposal for Miami-Dade County Marinas and Park Canoe and Kayak Launch Sites-Phase II, that it will carry out the Program in the manner described in the proposal and any plans and specifications attached thereto unless prior approval for any change has been received from the District.

3. That it has the ability and intention to finance its share of the cost of the project and that the project will be operated and maintained at the expense of said Miami-Dade-County for public use.

4. That it will not discriminate against any person on the basis of race, color or national origin in the use of any property or facility acquired or developed pursuant to this proposal, and shall comply with the terms and intent of the Title VI of the Civil Rights Act of 1964, P. L. 88-352 (1964) and design and construct all facilities to comply fully with statutes relating to accessibility by persons with disabilities as well as other federal, state and local laws, rules and requirements.

5. That it will maintain adequate financial records on the proposed project to substantiate claims for reimbursement.

6. That it will make available to FIND if requested, a post-audit of expenses incurred on the project prior to, or in conjunction with, request for the final 10% of the funding agreed to by FIND.

AND, BE IT FURTHER RESOLVED that the Board authorizes the County Mayor or County Mayor's designee to execute grant award agreements, amendments and other documents FIND and the grant require, following approval by the County Attorney's Office as to legal sufficiency; provided however that the County Mayor or Mayor's designee are only delegated the authority to execute amendments that do not have an additional fiscal impact on the County and that otherwise are for projects eligible under the FIND, Waterways Assistance Program. The Board authorizes the County Mayor or Mayor's designee to receive and expend all monies for the purposes described in the funding request for and on behalf of Miami-Dade County, Florida.

The proposed project for the application submitted to Florida Inland Navigation District, Waterways Improvement Program grant funding opportunity entails construction at four (4) Miami-Dade County Marinas: Black Point Marina, Herbert Hoover Marina at Homestead Bayfront Park, Matheson Hammock Marina, and Pelican Harbor Marina. The project is titled Miami-Dade County Marinas and Park Canoe and Kayak Launch Sites-Phase II.

This project will provide public waterfront access to Biscayne Bay and the Intracoastal Waterway. This project conforms to Miami-Dade County Parks and Open Space System Master Plan and the Miami-Dade County Waterfront Recreation Access Plan (WRAP), which is a vision for Miami-Dade County's Waterways. All proposed canoe and Kayak sites will adhere to the American Disabilities Act (ADA) accessibility guidelines. All canoe and kayak launch sites will be constructed to design criteria's which may include standardized 20 by 20 floating docks, concrete ramps, gangway connecting launch platform to shore, aluminum boarding handles, aluminum grab and launch rails, along with conventional piers and separated from boat traffic.

b) Explain how the project fits this priority category.

The priority category which best fits the proposed project is Acquisition, dredging, shoreline stabilization and development of public boat ramps and launching facilities. This project entails construction of canoe and kayak launch sites at four (4) Miami-Dade County Marinas: Black Point Marina, Herbert Hoover Marina at Homestead Bayfront Park, Matheson Hammock Marina, and Pelican Harbor Marina.

c) Explain how the project relates to the District's Waterways and the mission of the Florida Inland Navigation District.

Florida's Statewide Comprehensive Outdoor Recreation Plan, outdoor recreation is a public responsibility with a commitment through government with the goal of occupying the leisure time of its citizens. FINDS's mission, essentially is to assist local government in the development of waterway improvement projects such as the proposed project to construct canoe and kayak launch sites at four (4) Miami-Dade County Marinas: Black Point Marina, Herbert Hoover Marina at Homestead Bayfront Park, Matheson Hammock Marina and Pelican Harbor Marina.

1. **Black Point Marina** currently has 11 boat ramp lanes with 203 trailer parking spaces with 180 wet slips and 37 dry storage spaces.
2. **Herbert Hoover Marina at Homestead Bayfront Park** currently has 10 launch lanes with 261 trailer parking spaces with 178 wet slips and 30 dry storage spaces. Additional boater amenities include fish cleaning station, lease operated bait and tackle shop and a restaurant with meeting rooms.
3. **Matheson Hammock Marina** currently has a bait and tackle shop with 23 parking spaces, 10 boat ramps lanes 234 parking spaces 71 dry storage spaces 3 fuel pumps (gas and diesel) for boats a sewage pump out station and 243 wet slips on 9 docks, with 142 parking spaces and a rest room.
4. **Pelican Harbor Marina** currently has 8 boat ramp lanes and a boat ramp parking lot with 54 marked trailer spaces and 5 car spaces on the south side of the causeway. On the northside of the causeway there are 108 wet slips and 27 mooring field slips.

6. How many additional ramps, slips, parking spaces or other access features will be added by this project, and what is the approximate number of registered vessels estimated to use the constructed project?

Not applicable, the purpose of the proposed project is to increase participation of non-motorized watercraft.

7. Public Usage & Benefits:

- a) What public access or navigational benefit to the District's waterways will result from this project? How will this project enhance public access to the District's waterways, and what specific navigational benefits will it provide to the community?

The public access and navigational benefit to the District's waterways will result from the project adhering to the Florida Statewide Comprehensive Outdoor Recreation Plan and the (WRAP), as outdoor recreation is a public responsibility of government as a means of occupying the leisure times of its citizens. The proposed project conforms to FINDS's mission, in part to assist local government in the development of waterway improvement projects such as constructing canoe and kayak launch sites at four (4) Miami-Dade County Marinas: Black Point Marina, Herbert Hoover Marina at Homestead Bayfront Park, Matheson Hammock Marina, and Pelican Harbor Marina.

- b) What is the current demand for public access or navigation facilities in the area, and how does this project address unmet needs or improve upon existing facilities?

The current demand for public access is quantified as follows:
Black Point Marina- 18,603 is the approximate amount of boat launches based on revenue received for launch fees in the last 12 months.
Herbert Hoover Marina at Homestead Bayfront Park- 16,160 is the approximate amount of boat launches based on revenue received for launch fees in the last 12 months.
Matheson Hammock Marina- 16,182 is the approximate amount of boat launches based on revenue received for launch fees in the last 12 months.
Pelican Harbor Marina- 16,932 is the approximate amount of boat launches based on revenue received for launch fees in the last 12 months.
Existing facilities will be improved by constructing four Canoe & Kayak launch sites at Black Point Marina, Homestead Bayfront Park Marina, Matheson Hammock Marina, and Pelican Marina. The Canoe and Kayak Sites will be built to design criteria which may include standardized 20' by 20' floating docks, concrete ramps, gangway connecting launch platform to shore, aluminum boarding handles, aluminum grab and launch rails, along with conventional piers separated from boat traffic.

- c) How does the project fit within regional or local maritime management plans, public access initiatives, or comprehensive plans, and how does it contribute to broader public usage goals?

Miami-Dade County canoe and kayak launch sites for four (4) Miami-Dade County Marinas: Black Point Marina, Herbert Hoover Marina at Homestead Bayfront Park, Matheson Hammock Marina, and Pelican Harbor Marina provides immediate access to neighboring waterways and serves as a gateway to residents and visitors. Miami-Dade County Parks, Recreation and Open Spaces Department recognizes that outdoor recreation is a public responsibility to be met and are committed to providing continuous development efforts in waterway improvement projects as listed in the (WRAP). This project's goal is to construct canoe and kayak launch sites for public access.



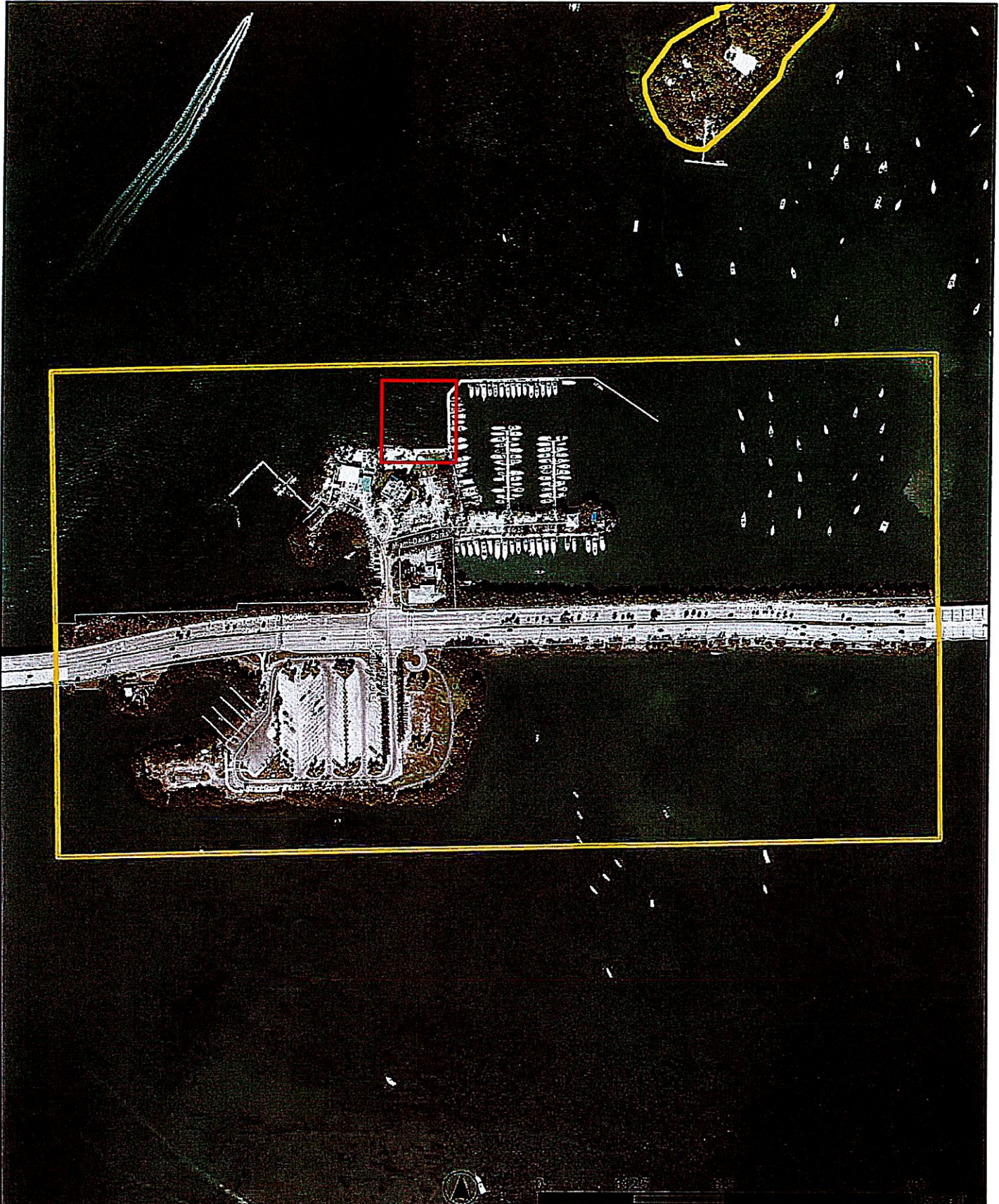
