Subject: Request for Additional Expenditure Authority to Prequalification Pool for Collision
Damage Body Work Repair Services

Summary

This item is requesting additional expenditure authority for the purchase of collision damage body work repair and paint services, and refurbishment and modification for various automotive equipment, including light, medium, and heavy-duty vehicles for multiple County departments. Additional allocation is required to continue performing body work repairs to the County's fleet after vehicles have been involved in accidents or collisions, or when body work repairs are required. The cost of parts and labor have increased since the pool was established. Additionally, due to the increased complexity and frequency of repairs needed, rebranding of Sheriff's vehicles and increases in the County's fleet, the initial allocation requested is not sufficient to cover the needs of the departments for the remainder of the pool term. Under the WISE305 initiative, this item was carefully scrutinized to ensure that the request is only for functional and essential repairs to support departmental operations, not purely cosmetic. In addition, the County's Fleet Management is undergoing a Kaizen analysis for the procurement and maintenance of vehicles to identify efficiencies and opportunities for continuous improvement.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve additional expenditure authority in the amount of \$13,480,000 for *Prequalification Pool No. RTQ-02121, Collision Damage Body Work Repair Services*, for multiple County departments.

Background

This pool was established by the Board on September 12, 2022, via Resolution No. R-801-22 in the amount of \$15,891,000 for a five-year term. The pool was subsequently modified under delegated authority. The pool includes two groups: Group 1 - Light Equipment Collision Damage Body Work, Repair, and Paint Services; and Group 2 - Medium and Heavy Equipment Collision Damage Body Work, Repair, and Paint Services. The services encompass general body frame and dent repairs, exterior and interior refurbishment, glass repair and replacements, alignments and paint services. Additional allocation is needed to support departments' operational needs as follows:

- Miami-Dade Aviation Department (MDAD) is requesting \$80,000 as the complexity and frequency of repairs needed on various light, medium, and heavy-duty automotive equipment, including Fire and Police vehicles, has required more labor hours than originally anticipated. Additionally, the unforeseen issues have extended the repair timeline, resulting in increased labor costs.
- People and Internal Operations Department (PIOD) is requesting \$10,600,000 for the remainder of the pool term. Based on PIOD's analysis, the department is requesting additional allocation due to higher cost of parts and labor rates, higher workload, and painting for the rebranding of the Sheriff's vehicles.

- Water and Sewer Department (WASD) is requesting an additional \$2,800,000 to continue purchasing parts used to repair existing County-owned heavy equipment and fleet. WASD's fleet has increased over the last two years from 2,400 to 2,603 light, medium, and heavy construction and utility equipment. During that same period, 455 vehicles were serviced for collision, accident, and body repairs. Higher costs for paint, materials, and labor rates associated with repairs are also contributing to the need for additional allocation.

Scope

The impact of this item is countywide in nature.

Delegated Authority

There is no additional delegation of authority sought in this item as the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38, and add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis, was granted when the pool was established. Any contract award under the prequalification pool exceeding \$5,000,000 is subject to ratification by the Board.

Fiscal Impact/Funding Source

The pool expires on September 11, 2027, and has a current cumulative allocation of \$18,391,000. If this request is approved, the pool will have a modified cumulative allocation of \$31,871,000. The proposed increase in expenditure authority is based on the historical usage patterns of the departments and their projected operational requirements for the remainder of the pool term.
