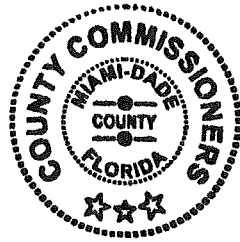
WHEREAS, Resolution No. R-226-21 provides limitations on the use of allocations from the Marlins Settlement Fund,
