Subject: Recommendation to Ratify a Contract Award for Cloth Media Filters under a Prequalification Pool to Aqua-Aerobic Systems, Inc.

This substitute item differs from the original item due to a clarification in the scope of work being done through this contract, by the vendor.

Executive Summary

This item seeks ratification by the Board of County Commissioners (the Board) of a contract award to Aqua-Aerobic Systems, Inc. (the Vendor) under Prequalification Pool No. RTQ-01360 for the purchase of Cloth Media Filters for the Miami-Dade Water and Sewer Department (WASD) in the amount of \$15,413,810.00. Purchase Order No. 376009 (the Contract) provides for the pre-purchase of the filtration technology required to achieve compliance with the Florida Department of Environmental Protection (FDEP) High-Level Disinfection (HLD) standards, in alignment with the Ocean Outfall Legislation (OOL) Program. The Contract also covers the storage, inspection of installation, and supervision of testing of the disk cloth filters that will be used to treat the secondary clarifier effluent wastewater at the North District Wastewater Treatment Plant (NDWWTP).

Consistent with my Administration's commitment to strengthening infrastructure, improving water quality through innovative technologies like HLD, and protecting the environment, WASD has accelerated its investment in the OOL Program by 400%. This bold action reflects our dedication to a cleaner, stronger, and more resilient Miami-Dade County, while ensuring long-term compliance with regulatory standards.

Recommendation

It is recommended that the Board ratify award of the Contract to Aqua-Aerobic Systems, Inc. for Cloth Media Filters in the amount of \$15,413,810.00. A copy of the Contract is attached hereto as Exhibit 1.

Scope

The NDWWTP is located within District 4, which is represented by Commissioner Micky Steinberg.

Fiscal Impact/Funding Source

The fiscal impact of this item is \$15,413,810.00. This will be funded by the Water Infrastructure Finance and Innovation Act (WIFIA).

Background

The Contract provides for the pre-purchase of filtration technology to meet the needs of the new NDWWTP HLD project. Each filtration technology has different requirements that affect the size, layout, electrical power requirements and other characteristics of the system. As a result, WASD has conducted evaluations prior to starting the design of the new NDWWTP HLD project to determine which technology would be best suited to achieve the goal of meeting the FDEP HLD requirements. The evaluation concluded that 10-mgd cloth media filters were best for WASD's project.

The Contract includes the procurement, storage, inspection of installation, supervision of testing of advanced disk cloth filtration systems. These filters provide tertiary treatment in wastewater processing by further removing suspended solids and enhancing water quality. The installation of these filters is a critical component of the HLD Project at the NDWWTP, which aims to meet more stringent effluent standards and support the County's long-term environmental and regulatory compliance goals.

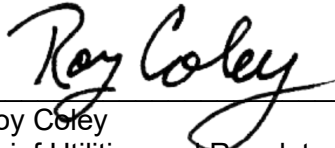
This Contract was solicited under Prequalification Pool No. RTQ-01360, Water and Wastewater Treatment Parts, Service and Equipment, which was approved by the Board via Resolution No. R-727-20 and is attached hereto as Exhibit 2. If this Contract award is not ratified by the Board, the Contract will be deemed terminated in which case the Contractor may be eligible for reasonable costs incurred prior to the notice of termination. In accordance with Section 2-8.1(b)(5) of the Code of Miami-Dade County, Florida, any contract award greater than \$5 million under an approved prequalification pool is subject to ratification by the Board.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Strategic Procurement Department's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues through various vendor responsibility lists and a keyword internet search. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to vendor responsibility.

Applicable Ordinances and Contract Measures

- The two percent User Access Program provision applies.
- The Small Business Enterprise Bid Preference applies.
- Local Preference does not apply.
- The Living Wage does not apply as the goods are not covered under the Ordinance.

Subject: Recommendation for Approval to Establish a Prequalification Pool for Water and Wastewater Treatment Parts, Services and Equipment

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the establishment of a prequalification pool, *RTQ-01360, Water and Wastewater Treatment Parts, Services and Equipment* for the Miami-Dade Water and Sewer Department (WASD). The current pool, 9138-5/19-5, was approved by the Board on February 2, 2010 for a five-year term, with five, one-year option to renew terms, through Resolution No. R-119-10, and is in its final option to renew term.

This replacement pool will provide for the purchase of liquid-solid separation and agitation equipment, parts, units, and repair services in conjunction with the needs of the department such as refurbishing of water production plants, installing filters for water production plants, and installing channel gates. WASD continually upgrades and maintains the County's water and sewer infrastructure to prevent deterioration and future service failures. Failure to maintain the infrastructure can result in cascading system failures throughout the County, which would create public health concerns.

Six vendors are being recommended for inclusion in the pool, of which three have local addresses and one is a Certified Small Business Enterprise firm. Ten vendors responded to the solicitation, including one "No Bid." The pool will remain open to allow additional vendors that meet the prequalification criteria to be added throughout the pool's term. Staff will continue to reach out to vendors to encourage additional vendor participation.

Scope

The scope of this item is countywide in nature.

Fiscal Impact/Funding Source

The term of the pool is for five-years. The fiscal impact for the first year is \$16,351,000. A modification will be presented to the Board at a later date when additional allocation is identified and needed for future years of the pool. The current pool, 9138-5/19-5, is valued at \$64,544,000 for a ten-year and six-month term and expires on August 31, 2020. The allocation under the replacement pool is higher than the current pool on an annualized basis due to projected usage by the Department, inclusive of upcoming anticipated projects.

Delegated Authority

Upon approval of this item, a pool of prequalified vendors will be established to participate in spot market competitions. The County Mayor or the County Mayor's designee will have the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board. The County

Mayor or the County Mayor's designee will also have the authority to (a) exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38 and (b) add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis.

Vendors Prequalified for Pool

A Request to Qualify was issued under full and open competition. A total of 7,001 vendors were invited to the advertised solicitation, of which 94 viewed it and 10 responded, including one "No Bid." Six vendors are being recommended for inclusion in the pool as set forth in the table below.

The pool includes three groups: Group A – Purchase of OEM and Non-OEM Parts and Equipment; Group B – Repair and Installation Services of OEM and Non-OEM Parts, and Equipment; and Group C – Rental of Water and Wastewater Treatment Units. No vendors are being recommended at this time for Group C because there were no responses for this group. Staff will conduct additional outreach in order to add vendors to Group C.

Pursuant to Resolution No. R-477-18, fewer than 75 percent of vendors recommended are local due to a diminished market.

Due Diligence

Pursuant to Resolution No. R-187-12, due diligence was conducted in accordance with the Internal Services Department's Procurement Guidelines to determine vendor responsibility, including verifying corporate status and that there are no performance and compliance issues. The lists that were referenced included convicted vendors, debarred vendors, delinquent contractors, suspended vendors, and federal excluded parties. There were no adverse findings relating to vendor responsibility.

Pursuant to Resolution No. R-140-15, prior to re-procurement, a full review of the scope of services was conducted to ensure the replacement pool reflects the County's current needs. The review included conducting market research, posting a draft solicitation for industry comment, and holding meetings and drafting sessions with the user department. The scope of services was updated to include a group for rental of water and wastewater treatment units based on feedback from Water and Sewer; however, no vendors have indicated the ability to provide those services at this time.

Applicable Ordinances and Contract Measures

- The two percent User Access Program provision applies where permitted by the funding source.
- The Small Business Enterprise (SBE) Bid Preference and Local Preference will be applied at the time of spot market competition where permitted by the funding source. An SBE set-aside applies for spot market competition up to \$100,000 where permitted by the funding source when there are three or more SBE-certified firms available.
- The Living Wage may apply to Group B for spot market purchases over \$100,000.

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

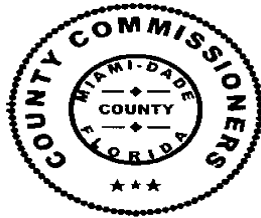
NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes the establishment of prequalification pool RTQ-01360 for Groups A, B, and C for the purchase of water and wastewater treatment parts, services and equipment for the Miami-Dade Water and Sewer Department in a total amount up to \$16,351,000.00 for the first year of the five-year term; and authorizes the County Mayor or County Mayor's designee to (a) solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, (b) exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the Code of Miami-Dade County, Florida and Implementing Order 3-38, and (c) add vendors to the pool at any time, subject

to ratification by the Board on a bi-annual basis. A modification will be presented to the Board when additional allocation is identified and needed for future years of the pool. A copy of the solicitation document and resulting contracts are on file and available upon request from the Internal Services Department, Strategic Procurement Division.

Subject: Request for Additional Expenditure Authority for Prequalification Pool No. RTQ-01360 Water and Wastewater Treatment Parts, Services and Equipment

Recommendation

It is recommended that the Board of County Commissioners (Board) authorize additional expenditure authority to Prequalification Pool No. *RTQ-01360, Water and Wastewater Treatment Parts, Services and Equipment* for the Water and Sewer Department. The Department is requesting \$65,402,000 in additional expenditure authority to continue purchasing water and wastewater treatment parts, services and equipment. The products will be used to support the County's water and wastewater plants, as well as its water distribution and wastewater collection systems.

The Board approved this prequalification pool on July 21, 2020, through Resolution No. R-727-20 for a five-year term, with an allocation of \$16,351,000 for the first year of the pool. At that time, the Board was informed that a modification would be presented when additional allocation was identified and necessary for future years of the pool. The pool was established with six vendors, of which three have local addresses. Since inception, four additional vendors have been added to the pool, of which two have local addresses. The pool currently has 10 prequalified vendors, of which five have local addresses and one is a certified Small Business Enterprise firm.

The Department has been using this pool extensively to support required operational and capital projects and has been purchasing various liquid-solid separation and agitation equipment, parts, units, and repair services throughout the past year. The allocation has also been used for installing filters for water production plants and installing channel gates. The Department continually upgrades and maintains the County's water and sewer infrastructure to prevent deterioration throughout the County, which would create public health concerns.

The additional expenditure authority is being requested to continue to facilitate the Consent Decree projects as mandated by the County's agreement with the United States Department of Justice, fund both operational and significant capital projects such as refurbishing water production plant lime kilns, filters at water production plants, structural rehab of secondary clarifiers at the North District Wastewater Treatment Plant and Central District Wastewater Treatment Plant, sludge gates, plant oxygenation trains, Ocean Outfall Legislation projects, and to support daily operations.

Scope

The impact of this item is countywide in nature.

Fiscal Impact/Funding Source

The pool term expires on August 31, 2025 and has a cumulative allocation of \$16,351,000. If this request for \$65,402,000 is approved, the pool will have a modified cumulative allocation of \$81,753,000. The requested increase in expenditure authority is based on anticipated usage throughout the remainder of the pool term.

Delegated Authority

There is no additional delegation of authority sought in this item as the authority to solicit pricing and award contracts up to an aggregate amount of the allocation authorized by the Board, exercise all provisions of the solicitation documents and any resulting contracts pursuant to Section 2-8.1 of the County Code and Implementing Order 3-38, and add vendors to the pool at any time, subject to ratification by the Board on a bi-annual basis, was granted when the pool was established under Resolution No. R-727-20.

Prequalified Vendors

The pool currently has 10 prequalified vendors, of which five have local addresses and one is a certified Small Business Enterprise firm. The pool includes three groups: Group A – Purchase of OEM and Non-OEM parts and Equipment; Group B – Repair and Installation Services of OEM and Non-OEM parts, and equipment, and Group C - Rental of Water and Wastewater Treatment Units. The inclusion of Group C in the solicitation was requested by the Department, as the rental of water and wastewater treatment units, such as belt presses and other dewatering equipment, may be needed in the future. This group would enable the Department to immediately source self-contained dewatering units which can be quickly mobilized to sites in the event one of the plants has a component failure and/or needs to augment its operations. Staff will continue to conduct outreach efforts in order to add vendors to Group C.

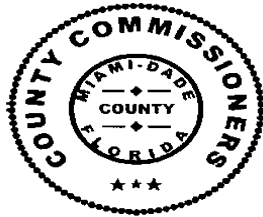
