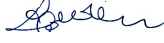

Subject: Resolution Approving the Plat of Presidential Estates West Filed by BH Lennar
Presidential, LLC

Recommendation

The following plat is submitted for consideration by the Board of County Commissioners (Board) for approval. This plat for Presidential Estates West is bounded on the north by NE 199 Street, on the east by NE 18 Avenue, on the south by NE 191 Street, and northwesterly by State Road No. 9.

The Miami-Dade County Plat Committee recommends approval of this plat. The Plat Committee is comprised of representatives from:

- Florida Department of Transportation;
- Florida Department of Health;
- Miami-Dade County School Board; and
- Miami-Dade County Departments of Fire Rescue; Parks, Recreation and Open Spaces; Regulatory and Economic Resources; Transportation and Public Works; and Water and Sewer.

Pursuant to Ordinance No. 16-73, this quasi-judicial matter may be submitted directly for placement on the Board's meeting agenda by the Director of the Department of Regulatory and Economic Resources.

A location sketch is attached to this memorandum as Exhibit A.

A full-scale copy of the plat and legal description of the boundaries of the land being subdivided, as well as the plat restrictions contained therein, are on file with the Department of Regulatory and Economic Resources.

Scope

This plat is located in Commission District 4, which is represented by Commissioner Micky Steinberg.

Delegation of Authority

There are no delegation requirements with this item.

Fiscal Impact/Funding Source

If this plat is approved, the fiscal impact to the county would be approximately \$1650.00 annually for the maintenance of new roadway construction adjacent to the project. These costs would be covered by the Department of Transportation and Public Works' annual General Fund allocation.

Track Record/Monitor

The Development Services Division within the Department of Regulatory and Economic Resources administers the processing of plats and waivers of plat, and the person responsible for this function is Raul A. Pino, P.L.S.

- Proposed Usage: 103 single family residences.
- Number of Parcels: 103.
- This plat meets concurrency.
- This residential development was determined to be within feasible distance to public water and public sanitary sewers using the feasible distance requirements in effect under the new feasible distance Ordinance No. 22-137.
- As a condition of this approval, the proposed development is required to connect to public water and public sanitary sewers.

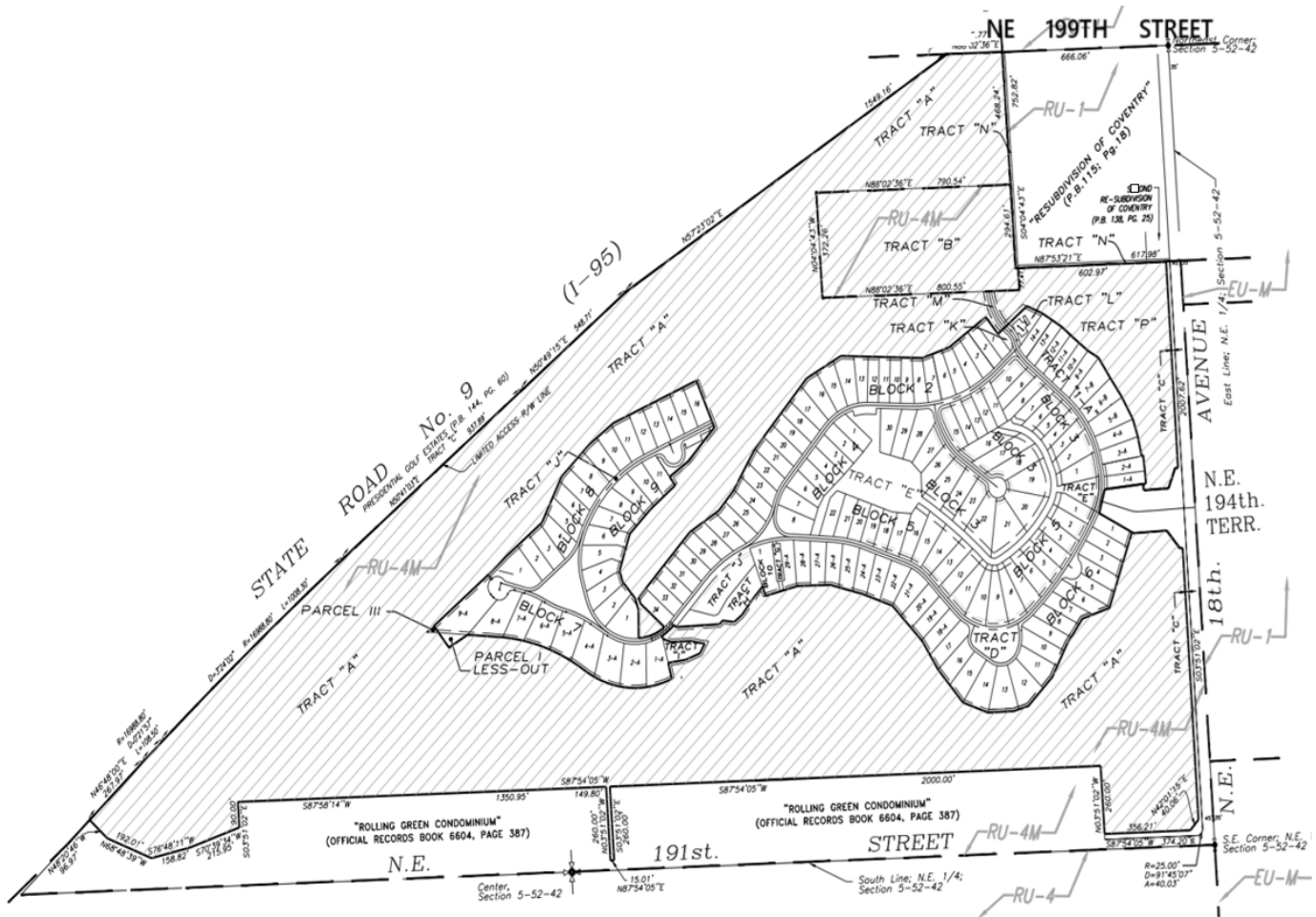

RESOLUTION NO. _____ R-645-25

RESOLUTION APPROVING THE PLAT OF PRESIDENTIAL ESTATES WEST FILED BY BH LENNAR PRESIDENTIAL ESTATES, LLC, LOCATED IN THE NORTH 1/2 OF SECTION 5, TOWNSHIP 52 SOUTH, RANGE 42 EAST (BOUNDED ON THE NORTH BY NE 199 STREET, ON THE EAST BY NE 18 AVENUE, ON THE SOUTH BY NE 191 STREET, AND NORTHWESTERLY BY STATE ROAD NO. 9)

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, BH Lennar Presidential, LLC, a Delaware limited liability company, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, said plat to be known as “Presidential Estates West,” the same being a replat of a portion of Tract “A”, all of Tracts “B” and “M”, “Presidential Estates Subdivision,” according to the plat thereof as recorded in Plat Book 151, at Page 67, Tract “P”, Presidential Estates Replat No. 4, according to the plat thereof as recorded in Plat Book 155, at Page 76, and a portion of Lot 9-A, Block 7, “Presidential Estates Replat No. 3, according to the plat thereof as recorded in Plat Book 155, at Page 75, all of the Public Records of Miami-Dade County, Florida, lying and being in the North 1/2 of Section 5, Township 52 South, Range 42 East, Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or

depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations; and that the requirements of the zoning existing on this land at the time this resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements.

The foregoing resolution was offered by Commissioner **Oliver G. Gilbert, III** , who moved its adoption. The motion was seconded by Commissioner **Marleine Bastien** and upon being put to a vote, the vote was as follows:
