RESOLUTION APPROVING THE CITY OF HIALEAH'S
CODESIGNATION OF THAT PORTION OF WEST 2ND
AVENUE BETWEEN 49TH STREET AND 45TH STREET AS
"FAMILIA DE PRESOS POLITICOS CUBANOS STREET"

WHEREAS, the Mayor and the City Council of the City of Hialeah passed Resolution No. 2025-085 on March 25, 2025, which codesignated that portion of West 2nd Avenue between 49th Street and 45th Street as "Familia de Presos Politicos Cubanos Street" in recognition of Cuban families that have been affected by the deaths of political prisoners; and

WHEREAS, a copy of Resolution No. 2025-085 is attached hereto and incorporated by reference; and

WHEREAS, that portion of West 2nd Avenue between 49th Street and 45th Street is a city road located in the City of Hialeah; and

WHEREAS, this codesignation is located in County Commission District 13; and

WHEREAS, the City of Hialeah would like for the County to install signage indicating this codesignation on County street signs and traffic signal mast arms; and

WHEREAS, this Board would also like to recognize Cuban families that have been affected by deaths of political prisoners by approving the City of Hialeah's codesignation of that portion of West 2nd Avenue between 49th Street and 45th Street as "Familia de Presos Politicos Cubanos Street",

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Hialeah's codesignation of that portion of West 2nd Avenue between 49th Street and 45th Street as "Familia de Presos Politicos Cubanos Street".

Section 2. Directs the Clerk of the Board to send certified copies of this resolution to the Mayor and City Council of the City of Hialeah, the United States Postal Service, the Traffic Signals and Signs Division of the Department of Transportation and Public Works, the Development Services Division of the Regulatory and Economic Resource Department, the City of Hialeah Police Department, and the City of Hialeah Fire Department.

The Prime Sponsor of the foregoing resolution is Senator René García. It was offered by Commissioner **Sen. René García**, who moved its adoption. The motion was seconded by Commissioner **Juan Carlos Bermudez** and upon being put to a vote, the vote was as follows:

Section 1: The recitals contained in the preamble to this Resolution are hereby incorporated and adopted by reference as if fully set forth herein.

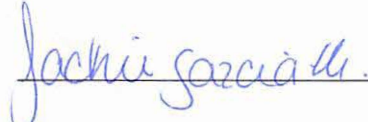
