RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO DISBURSE \$250,000.00 IN GRANT FUNDING APPROVED IN RESOLUTION NO. R-210-25 FOR ALLOCATION TO THE DEPARTMENT OF CULTURAL AFFAIRS FOR THE DEVELOPMENT OF THE FLORIDA BLACK HISTORY MUSEUM IN MIAMI-DADE COUNTY TO TEN NORTH GROUP

WHEREAS, at the June 26, 2025 Board of County Commissioners meeting, a motion was made directing the County Mayor or County Mayor's designee to disburse the \$250,000.00 in grant funding approved in Resolution No. R-210-25 for allocation to the Department of Cultural Affairs for the development of the Florida Black History Museum in Miami-Dade County to Ten North Group,
