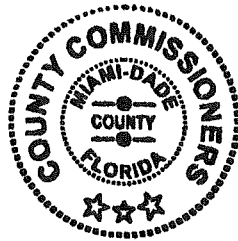
WHEREAS, Resolution No. R-238-21 provides limitation on the use of allocations from the Arena Naming Rights Fund,
