Subject: Scheduling of the Public Budget Hearings

Executive Summary

This item seeks approval to set the Public Budget Hearing dates for use in the preparation of the "Notice of Proposed Property Taxes" to be mailed to all property owners in August.

Recommendation

It is recommended that the Board of County Commissioners (Board) approve 5:01 p.m. on Thursday, September 4, 2025, and 5:01 p.m. on Thursday, September 18, 2025, as the Public Budget Hearing dates for use in preparing the "Notice of Proposed Property Taxes" to be mailed to all property owners in August.

Scope

State law requires that all property owners be advised of proposed property taxes along with notification of public budget hearings. The Property Appraiser will mail required notices to all property owners in August using proposed tax rates adopted by all taxing authorities in Miami-Dade County.

Background

The County's public budget hearings have been tentatively scheduled on the Board's official calendar for 5:01 p.m. on Thursday, September 4, 2025, and 5:01 p.m. on Thursday, September 18, 2025, in the Commission Chambers, Stephen P. Clark Center, 111 NW 1st Street, Miami, Florida. The School Board has scheduled its final budget hearing for September 10, 2025. By virtue of this action, these dates will be provided to the municipalities, which cannot hold their budget hearings on the same date as the County or the School Board. This item seeks approval to set the dates for the Public Budget Hearings in order to complete the preparation of the "Notice of Proposed Property Taxes" that will be mailed to all property owners in August.

WHEREAS, section 200.065, Florida Statutes, establishes and describes the requirement that the governing body of each taxing authority hold public hearings on the tentative budget and proposed millage rates, and requires that, within 35 days of certification of value by the Property Appraiser, each taxing authority advise the Property Appraiser of its proposed millage rate and rolled-back rate and of the date, time, and place at which a public hearing will be held to consider the proposed millage rates and tentative budget so that the information can be included in the notice of proposed property taxes mailed to property owners in August; and

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum from the County Mayor, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Fiscal Year 2025-26 public budget hearings are scheduled for September 4, 2025, at 5:01 p.m. and September 18, 2025, at 5:01 p.m. in the Commission Chambers, Stephen P. Clark Center, 111 NW 1st Street, Miami, Florida.
