RESOLUTION DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PROCURE AN ADDITIONAL INDEPENDENT CONSULTANT TO EVALUATE POTENTIAL COST SAVINGS OF PROPOSALS SUBMITTED IN RESPONSE TO RFP NO. EVN0004282, FOR THE PROVISION OF FULL ADMINISTRATIVE SERVICES FOR THE COUNTY'S SELF-FUNDED EMPLOYEE GROUP HEALTHCARE PROGRAM

WHEREAS, at the July 16, 2025 Board of County Commissioners meeting, a motion was made to direct the County Mayor or County Mayor's designee to procure an additional independent consultant to evaluate the potential costs savings of the proposals submitted by AvMed, Inc. and Aetna Life Insurance, respectively, in response to RFP No. EVN0004282, for the provision of full administrative services for the County's Self-Funded Employee Group Healthcare Program, and to provide the results of such evaluation to this Board prior to the consideration of the award of any contract for such administrative services,
