RESOLUTION, BY A TWO-THIRDS VOTE OF BOARD MEMBERS PRESENT (1) AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR’S DESIGNEE TO ENTER INTO A CONTRACT MODIFICATION FOR CONTRACT NO. FB-01293 FOR VEHICLE RENTAL SERVICES WITH ROYAL RENT A CAR SYSTEMS OF FLORIDA, INC. (“ROYAL”) AND ENTERPRISE LEASING COMPANY OF FLORIDA, LLC (“ENTERPRISE”) TO (A) EXTEND THE CONTRACT FOR A TERM OF FIVE YEARS, (B) AMEND THE RENTAL RATE SCHEDULE FOR ENTERPRISE, AND (C) RENEW, AT HIS OR HER DISCRETION, THE CONTRACT FOR AN ADDITIONAL TERM OF UP TO FIVE YEARS, ALL SUBJECT TO THE COUNTY MAYOR FILING WITH THE CLERK OF THE BOARD A WAIVER OF FORMAL BID PROCEDURES PURSUANT TO SECTION 5.03(D) OF THE HOME RULE CHARTER AND NON-COMPETITIVE BID WAIVER PROVISIONS OF SECTION 2-8.1(B)(1) OF THE CODE OF MIAMI-DADE COUNTY; (2) FINDING THE WAIVER OF COMPETITIVE BIDS TO BE IN THE BEST INTERESTS OF MIAMI-DADE COUNTY; (3) AUTHORIZING THE COUNTY MAYOR OR COUNTY MAYOR’S DESIGNEE TO EXECUTE THE CONTRACT MODIFICATION AND EXERCISE ALL PROVISIONS CONTAINED THEREIN; (4) AUTHORIZING ADDITIONAL EXPENDITURE AUTHORITY UP TO \$8,420,395.00 FOR A TOTAL MODIFIED CONTRACT AMOUNT OF \$41,017,417.00; (5) DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR’S DESIGNEE TO PROVIDE A REPORT TO THIS BOARD NO LATER THAN SEPTEMBER 30, 2025 IN THE EVENT THAT THE COUNTY MAYOR OR COUNTY MAYOR’S DESIGNEE DOES NOT FILE THE BID WAIVER WITHIN SUCH TIME; AND (6) DIRECTING THE COUNTY MAYOR OR COUNTY MAYOR’S DESIGNEE TO SEEK ADDITIONAL EXPENDITURE AUTHORITY FOR THE RENEWAL OF THE CONTRACT, AS NEEDED

WHEREAS, at the September 3, 2025 Board of County Commissioners meeting, a motion was made to, by a two-thirds vote of the Board members present: (1) authorize the County Mayor or County Mayor’s designee to enter into a contract modification for Contract No. FB-01293 for

Vehicle Rental Services (the “Contract”) with Royal Rent A Car Systems of Florida, Inc. (“Royal”) and Enterprise Leasing Company of Florida, LLC (“Enterprise”) to (a) extend the Contract for a term of five years, (b) amend the rental rate schedule for Enterprise, and (c) renew, at his or her discretion, the Contract for an additional term of up to five years, all subject to the County Mayor filing with the Clerk of the Board a waiver of formal bid procedures pursuant to section 5.03(D) of the Home Rule Charter and non-competitive bid waiver provisions of section 2-8.1(b)(1) of the Code of Miami-Dade County; (2) find the waiver of competitive bids to be in the best interests of Miami-Dade County; (3) authorize the County Mayor or County Mayor’s designee to execute the contract modifications and exercise all provisions contained therein; (4) authorize additional expenditure authority up to \$8,420,395.00 for a total modified Contract amount of \$41,017,417.00; (5) direct the County Mayor or County Mayor’s designee to provide a report to this Board no later than September 30, 2025 in the event that the County Mayor or County Mayor’s designee does not file the bid waiver within such time; and (6) direct the County Mayor or County Mayor’s designee to seek additional expenditure authority for the renewal of the Contract, as needed,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board, by a two-thirds vote of Board members present:

Section 1. Authorizes the County Mayor or County Mayor’s designee to enter into a contract modification for Contract No. FB-01293 for Vehicle Rental Services (the “Contract”) with Royal Rent A Car Systems of Florida, Inc. (“Royal”) and Enterprise Leasing Company of Florida, LLC (“Enterprise”) to (a) extend the Contract for a term of five years, (b) amend the rental rate schedule for Enterprise, and (c) renew, at his or her discretion, the Contract for an additional term of up to five years, all subject to the County Mayor filing with the Clerk of the Board a waiver

of formal bid procedures pursuant to section 5.03(D) of the Home Rule Charter and non-competitive bid waiver provisions of section 2-8.1(b)(1) of the Code of Miami-Dade County and finds the waiver of competitive bids to be in the best interests of Miami-Dade County. The contract modifications are attached hereto as Attachment 1.

Section 2. Authorizes the County Mayor or County Mayor's designee to execute the contract modifications and exercise all provisions contained therein.

Section 3. Authorizes additional expenditure authority up to \$8,420,395.00 for a total modified contract amount of \$41,017,417.00 for the Contract.

Section 4. Directs the County Mayor or County Mayor's designee to provide a report to this Board no later than September 30, 2025 in the event that the County Mayor or County Mayor's designee does not file the bid waiver within such time.

Section 5. Directs the County Mayor or County Mayor's designee to seek additional expenditure authority for the renewal of the Contract, as needed.

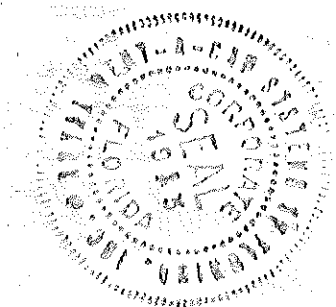

At the September 3, 2025 Board of County Commissioners (Board) meeting, a motion was approved by a two-thirds vote of the Board members present authorizing the County Mayor or County Mayor's designee to enter into a contract modification for *Contract No. FB-01293, Vehicle Rental Services* (the Contract), with Royal Rent A Car Systems of Florida, Inc. (Royal) and Enterprise Leasing Company of Florida, LLC (Enterprise) to extend the Contract for a term of five years and amend the rental rate schedule for Enterprise, subject to the County Mayor's written recommendation pursuant to Section 2-8.1 of the Code of Miami-Dade County (Code) and Section 5.03(d) of the Home Rule Charter. The motion included the following provisions:

- Extension of the Contract for a term of five years;
- Amendment of the rental rate schedule for Enterprise;
- Authorization for the County Mayor or County Mayor's designee to renew the contract, at his/her discretion, for an additional term of up to five years;
- Authorization of additional expenditure authority in the amount of \$8,420,395, increasing the total Contract amount to \$41,017,417;
- Directing the County Mayor or County Mayor's designee to seek additional expenditure authority for the renewal term from the Board, as needed.

The above provisions are subject to the County Mayor filing, with the Clerk of the Board, a recommendation to waive of formal bid procedures pursuant to Section 5.03(D) of the Home Rule Charter and non-competitive bid waiver provisions of Section 2-8.1(b)(1) of the Code.

In accordance with the Board's motion, I recommend the waiver of competitive bidding procedures pursuant to Section 2-8.1 of the Code and Section 5.03(d) of the Home Rule Charter. This waiver of competitive bidding will ensure continuity of essential vehicle rental services for County operations and reduce administrative burdens related to returning and exchanging existing rental vehicles, while also providing significant savings to the County. The extension and modification of this Contract with fixed and firm rates for the extended five-year term (subject to annual Producer Price Index adjustments permitted pursuant to the Contract) are in the best interest of Miami-Dade County.
